### SRT Certification Process & Policies

At the January meeting, the Team Commanders will present a formal certification process to the Board. The SOP's are on their third revision and the fourth, and hopefully final, will be delivered for Board approval in January 2006.

### SRT Training

The 8-day Patriot training for 22 team members will be held in Urbana from January 9-17, 2006. Each of the ten teams will have 2 members in attendance with one slot open for Chicago and one for ISP. The teams are scheduling the WMD Tactical Operators course for each of their regions.

Additionally, the new online training software is now active. Team commanders can build their teams online and enter their training events. Each time they do, an email is automatically generated and sent to each chief and sheriff of the affected officers. The chiefs/sheriffs can then request a reimbursement online as well.

### SRT New Teams

We have met with the Central Illinois Emergency Response Team (CIERT) which is a pre-existing multi-jurisdictional team based around the Peoria/Tazewell/Woodford counties area. They will have a final answer for the ILEAS Board by the time of the December meeting. Additionally, work is being done to put together a team on the southwest side of the Chicago area. More will follow on that as it happens.

### SRT Budget

The SRT budget for FY 05 started at \$4.5 million and is now down to \$2.4 million. Most major purchases are completed – robots, trucks, trailers, patriots – are all done. There are some SCBA issues outstanding and the basic equipment and radios for the two new teams have yet to be ordered.

### StarCom 21 and VHF Radios

StarCom21 radios are being installed all over the State. ILEAS has not received a bill as of yet. I have posted a web page regarding the StarCom21 and VHF radio projects complete with checklists, FAQ's, lists of agencies who requested each, policies, etc. Here are the issues that have surfaced so far:

- Agencies that do not know what StarCom21 is and didn't know they ordered it
- Agencies that said they ordered it but were not on the list (there are probably half a dozen so far)
- Agencies that Motorola cannot find, contact or otherwise get in touch with. The ILEAS staff has been assisting by tracking them down and getting them hooked up with Motorola.

### Regional Distribution Sites Security Teams

ILEAS has posted a RDSST website and sent out a bulk email to all sheriffs/chiefs about the RDSST's. We have gotten several inquiries from departments that are interested in forming a team. Additionally, a formal letter was sent to OPD from Carl Hawkinson requesting a waiver from the prohibition on chemical riot control agents for these teams. The budget and the team formation is on hold until an answer is received with regard to this waiver request.

### Mobile Command Posts

The Mobile Command Posts are being completed quickly at this point. The Adams County MCP will be delivered shortly and two more (Galesburg and Jo Davies County) are being completed. They will keep one of them as a template and then build two more. This is the schedule:


**Credentialing**
