Federal Presidential Budget Proposal For FFY2018

Grant Program	2017	2018	%Change
State Homeland Security Grant Program	\$467 million	\$349 million	-25%
Urban Area Security Initiative	\$605 million	\$449 million	-25%

Proposed 25% cost share/match per state

Two types of matching funds:

- Soft = in-kind staff time & services
- Hard = cash - \$21 million for Illinois for level funding



Collecting Local Share Data

Responding to Mutual Aid Requests = \$65,595

IL. Terrorism Task Force Council of Chairs

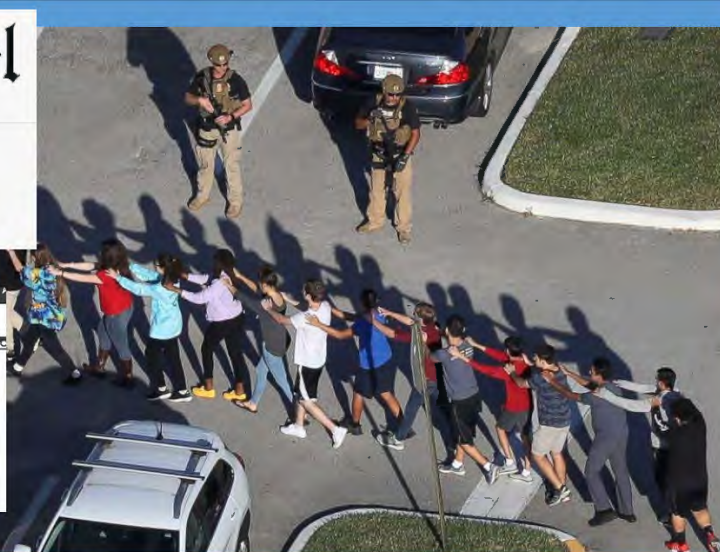
- ✓ **Developed 40-page report documenting what federal grants do not address**
 - Capital Replacement
 - Operational Expenses
 - Statutory Changes
- ✓ **ILEAS identified 388 special teams and mutual aid requests in 2017**
- ✓ **Submitted to Governor's Office December 2017**
 - Governor placed \$2.5m in State Budget as an annual budget to address those needs
 - General Assembly must adopt that proposal

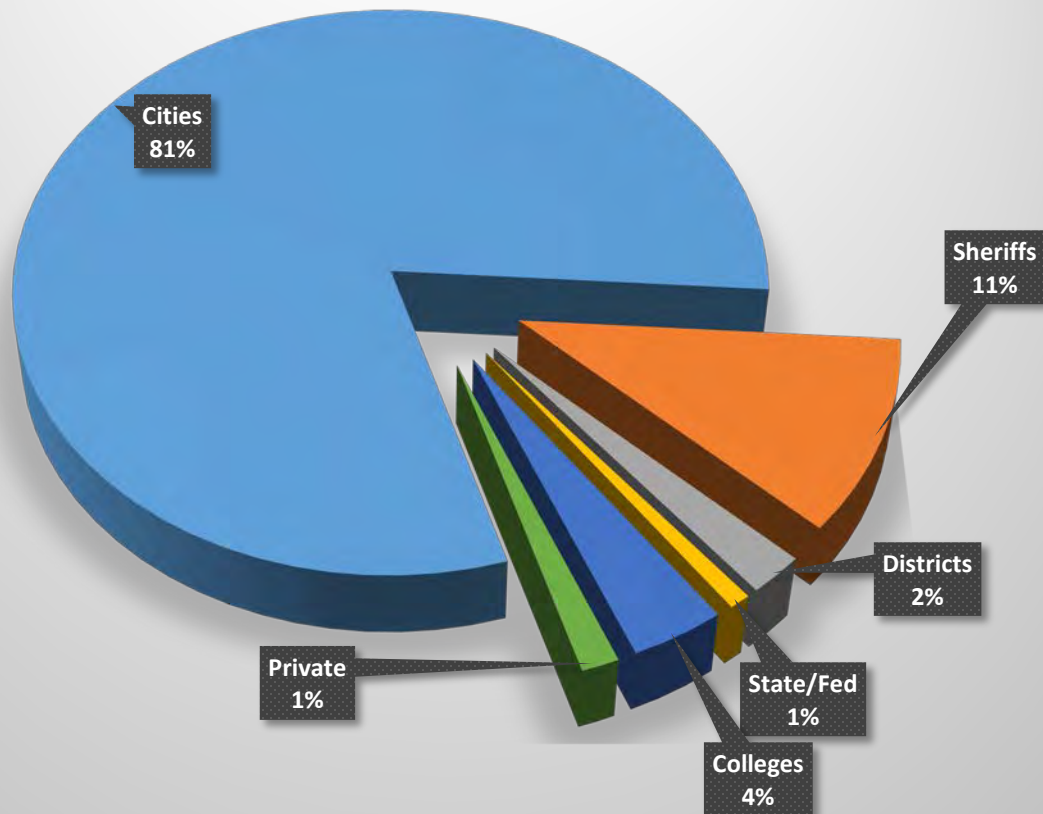

- 4 Federal Agencies



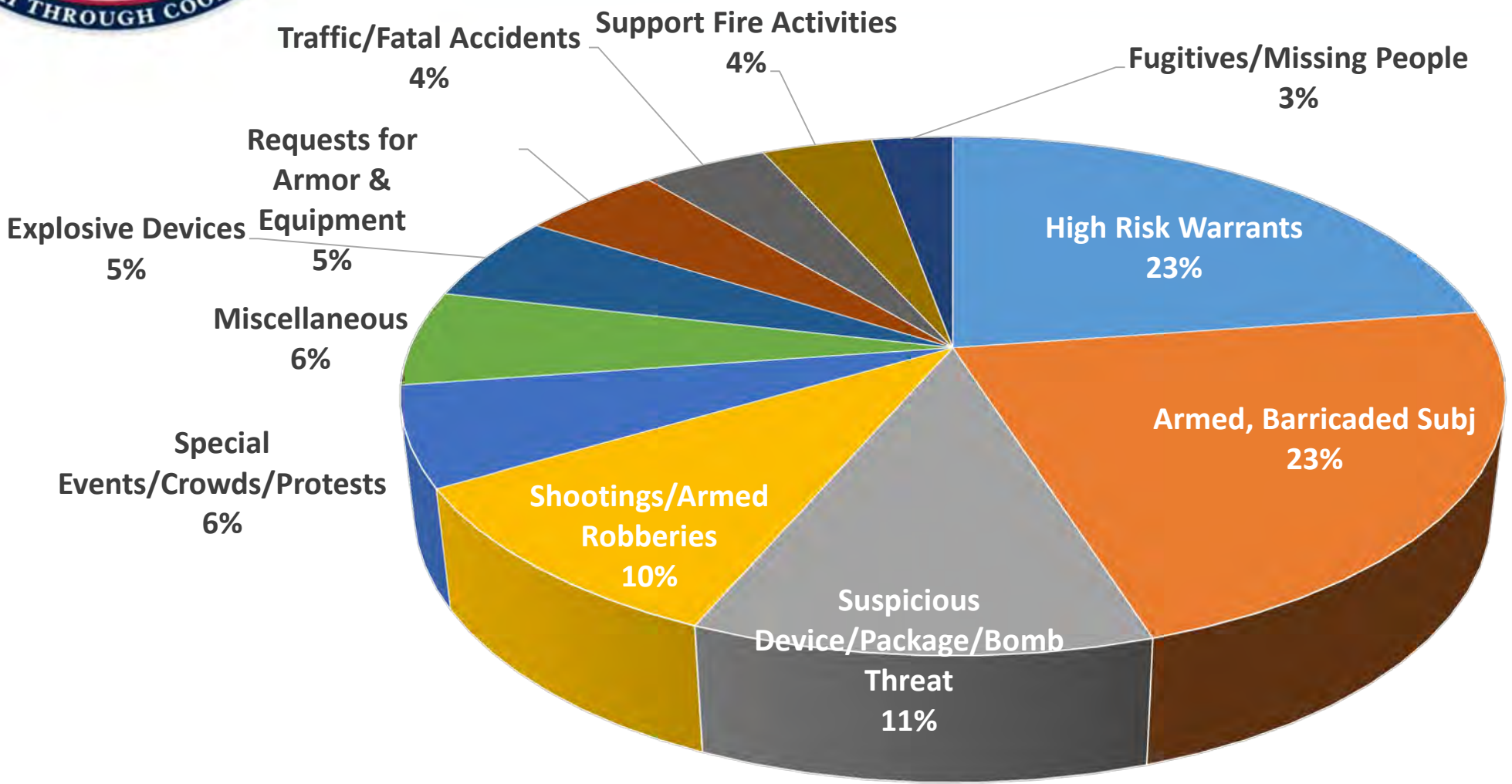

715 agencies kept their STARCOM21 Radio assuming network fees

136 Com21 Mobile Radios were supplied to MABAS Special Teams statewide in 2017



144 Repurposed StarCom21 portables were used to create 12 Caches for Unified Command Posts (UCP) across the State in 2017



240 Repurposed StarCom21 Mobile and Base Radios were Distributed to agencies in 2017. These agencies agreed to pay their own network access fees.

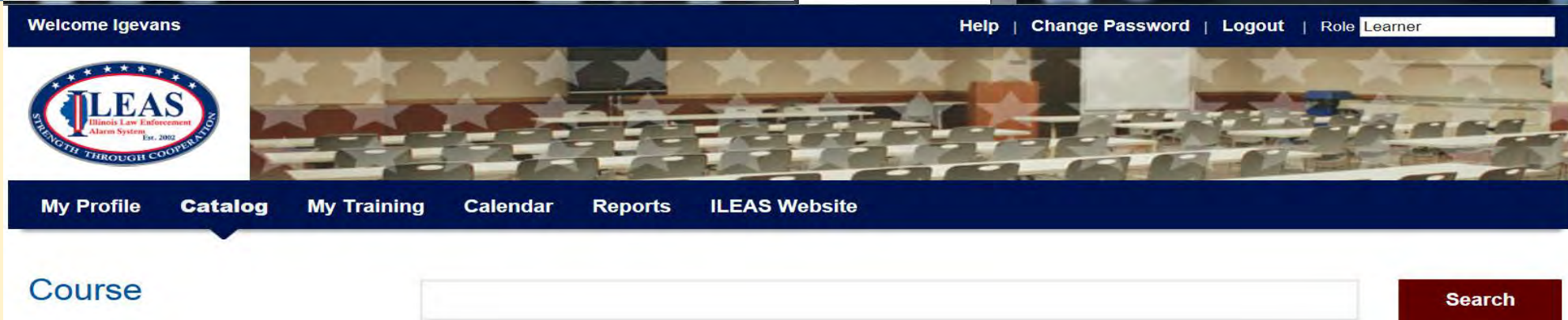

FirstNet

- ✓ Governor Rauner signs “opt-in” for Illinois on 12/18/17
- ✓ AT&T providing FirstNet services
- ✓ Will be improved over time to “public safety grade”
- ✓ There is no law/rule requiring any agency to use FirstNet
 - Each agency can choose the best provider for its needs
 - This includes cost, coverage & features
- ✓ FirstNet is not a viable replacement for public safety radios
 - Experts believe this to be at least a decade away
- ✓ FirstNet staff at ILEAS still exist to assist anyone with questions they may have about the system, transitioning, features, etc.
