Greg is also responsible for very important case law that better enables officers to do this work including the now important United States v. Morgan, Walker, Jones and State v. Barbeau. He still works the road in the Uniform Division and still actively pursues these criminals during his everyday encounters. He also still works with other officers who have had tremendous success using these techniques.
