Jail Intake Screening: Where Jail Liability Starts: Jails now face multiple challenges with the deadly drugs that arrestees either have taken, concealed on them or attempt to smuggle into jail that puts more emphasis on the intake officers completing a very detailed, documented screening. Not only drugs, but also with the serious mental health illness, or a combination of both, even complicates their jobs as it seems that jails have become the last resort to take mental health persons. But having an in-depth screening and assessment tools in place in addition to the officers observations, not only helps the officer but also lessens the liability for the jail and possibly save a life. The intake officers has first contact with the arrestee and plays a very vital role in getting the correct information from screening. It is imperative that intake officers complete accurate screening process in addition with their observations. This course will start from taking legal custody of the arrestee thru the intake screening process and assessment to how classification will use that information for housing.

Jail Classification: Today, jails having an objective classification system is an essential part of ensuring the safety and security of any facility. With an objective classification system, there can be a lower risk of litigation and a safer jail for both staff and inmates. The training will start with an overview of the history and evolvement of classification and housing inmates. There will be an overview of what an Objective Jail Classification System should include and why a valid objective system should be used over an subjective classification system. The training will also include changing requirements and use of Restrictive Housing to include certain inmate population where it should be used only as a last option

Special Housing: In this block training, I focus on suicide, mental health and detoxing while in jail. We discuss the high risk inmates and why doing assessments and doing them correctly can be life or death for some inmates and it should start in Intake but not stop there and continue throughout the inmates incarceration. We also review some cases where this wasn't done to see where the failure was and to what could have been done differently.

Restrictive Housing of Jail Inmates: Lock-Down, Solitary Confinement, Administrative Segregation or Disciplinary Segregation no matter what it is called in your facility it still can be harmful if used for long term. How it is defined and the effects of using long term will be discussed along with a review of the guidelines of using restrictive housing. Many states have already taken action for reducing restrictive housing and the push for reducing restrictive housing for certain special housing inmates all together. Those changes will be discussed as well as why the push for limits on the use of restrictive housing.

De-Escalation: In this block training, we go over practical and empathetic communication techniques designed to help manage challenging situations without the need or limited need for force. We will cover effective verbal strategies, body language, and active listening skills—all critical components in reducing tension and fostering a cooperative environment. I will highlight how the tone of your voice, choice of words, and even pacing can influence the emotions of someone in distress. You'll learn the importance of using open-ended questions to encourage dialogue and engage the individual meaningfully. And showcase how posture, gestures, and facial expressions play a crucial role in the communication process. Listening is just as important as speaking. By using active listening skills can significantly reducing escalation potential. **Inmate Manipulation:** In this block training, we cover the techniques that inmate use to manipulate, how they select their targets, how to recognize the signs of an officer that is being manipulated along with how to stop it from occurring. We review two high profile cases of staff members that were manipulated and the signs that were overlooked or not recognized. We review and discuss a video of an inmate telling what they look for and how the select targets and what officers have done to stop the manipulation from occurring. And one part we discuss is also how staff manipulates other staff members to get the inmate's request from being manipulated. **Leadership:** In this block training, we look at what makes a good leader vs a bad leader. We reflect on our own experiences and what has worked and what has not worked in the

<u>Leadership:</u> In this block training, we look at what makes a good leader vs a bad leader We reflect on our own experiences and what has worked and what hasn't worked in the past, our own emotional intelligence and experiences that we do to reflect on good leadership qualities. We review the different aspects of becoming a leader with ethics, power, influence and cultural.

<u>Stress Management:</u> In this block of training, I focus on the person as an individual on the stress of working in law enforcement, how to recognize it and what steps to do to control what you can. We look at self- awareness and complete a small assessment for individual assessment of oneself. We discuss work and family life balance and why that is important. Thought, there are techniques shown that can be done at work when you feel stress building up.
