Instructor Background Information

Lt. Jim Glennon (Ret.)

Lt. Jim Glennon, the third generation in a family of law enforcement officers, began his career in 1980 with the Lombard Police Department. Retiring as a Commander, Jim held positions as a patrol officer, detective, sergeant, and Commander of the Investigations Unit. In 1998, he was selected as the first Commander of Investigations for the newly formed DuPage County Major Crimes Task Force. Jim has a Bachelor's Degree in Psychology and a Master's Degree in Law Enforcement Justice Administration from Western Illinois University. He attended the School of Police Staff and Command at Northwestern University where he was elected class president, received the prestigious Kreml Leadership Award, and began teaching for Northwestern within months of completing the 400-hour course.

Jim taught the Calibre Press Street Survival Seminar for eight years and served as both Lead Instructor and Director of Curriculum. In 2012 Jim's company, LifeLine Training, acquired Calibre Press and the Street Survival Seminar. He is the first law enforcement officer to own the company in its 30-year history. Teaching various courses for both law enforcement and private industry, Jim specializes in seminars that deal with officer safety, interaction skills, and leadership. Jim is a featured writer for both Law Officer Magazine and lawofficer.com. He is the author of the book, *ARRESTING COMMUNICATION:* Essential Interaction Skills for Law Enforcement.

Lt. Kelly DeVoll

Lt. Kelly DeVoll is a 23-year veteran of law enforcement, beginning his career with the Jefferson County (Texas) Sheriff's Department in May 1989. Since entering law enforcement, Kelly has served as a corrections officer, patrol officer, D.A.R.E. officer and supervisor, SWAT operator, forensic crime scene supervisor, patrol sergeant, school resource officer, and law enforcement trainer. He has been teaching law enforcement courses since 1992.

Kelly started working for the Georgetown (Texas) Police Department in July 1998 and is currently serving as the agency's Professional Standards Division Commander, Lead Firearms Instructor, and Emergency Response Team Commander. He was responsible for the development of the tactical team at Georgetown PD and has served as Tactical Commander since the team was organized in 2000.

Kelly teaches numerous law enforcement courses throughout the United States and Canada. He also teaches Crisis Communications for public safety dispatchers.
