Inventory

Inventory began on May 1, 2007. All the WMD SRT teams have had their equipment personally inventoried by Jennifer Ford. Six Field Inventory Inspectors, supervised by Jennifer Ford, were hired and started the annual inventory audit. The Field Inspectors contacted all agencies that had not self-certified in an effort to get them to certify. They also assisted in the recruiting of non-member agencies. As of July 23rd, there were 66 agencies left to certify out of over 900. At the end of July, only one field Inspector will remain on the ILEAS payroll. the 2006 Annual inventory audit will be submitted to the State on July 31, 2007.

Communications

- Dave Owens continues to work with agencies to get their StarCom and VHS radio programs working. Additionally, he has:
- Worked with Motorola and the SRT teams to get their communications issued straightened out
- Assisted ILEAS staff with StarCom21 questions and inquiries from local agencies
- Worked on the State Interoperability Executive Committee (SEIC) and the ITTF Communications Committee to develop an interoperability plan for submission to DHS so that Illinois can gain access to the PSIC grant funds

Jennifer Ford has recently found homes for all 43 the StarCom21 consolettes. They ended up primarily in dispatch centers throughout Illinois. She also keeps track of the StarCom21 radio requests which have slowed down considerably recently.

Grants

I managed this years local law enforcement grants. I have assisted in the approval and distribution of Mobile Data Computers as well as Thermal Imagers. One group receiving the "law enforcement" thermal imagers has already received their training as well as their equipment. The other group receiving the "fire" thermal imagers will receive their equipment and training soon.

Gas Masks

AVON FM12 respirators are continuously coming in to the ILEAS office as well. These are being organized and filed until we are able to fill them. At this point, staff has 470 mask orders and 112 monocle orders. ILEAS did take possession of 211 additional masks from Peoria. ILEAS will make an order of 259 masks in the next two weeks to fill all orders.

- A MCATI Protestor Device course was held June 5-7 at Rantoul.
- A Less Lethal/Chemical Train the Trainer is scheduled for October 01-05. It is tentatively scheduled to be held in Kankakee.

WMD Special Response Teams

Equipment

- Team Decon has been ordered and is scheduled for delivery in August.
- Dave Owens working with Motorola developed a programming template for team radios. Motorola is in the process of programming all of the SRT team radios with this template.
- Team leaders developed a priority for future purchases: Cost estimates in parenthesis.
 - Maintenance/replacement of team equipment (\$500,000)
 - Team transport vehicles (\$1.25 million)
 - Air refill capability (\$1.5 million)
 - Patriots for all team members (\$3 million)
 - Night vision for all members (\$1.75 million)

- Advanced tactical training (\$200,000 probably cannot be DHS funds)
- Gore suits (\$1.5 million)

Training

- Basic SWAT held April 18-27 2007 in Rantoul, Urbana and Champaign.
- IFSI continues to work on an SRT oriented Haz-Mat course. However we are now sending team members to the Center for Domestic Preparedness in Anniston, Alabama for their Haz Mat training.
- Patriot maintenance course held June11-13 in Rantoul.
- Tac Commanders course to be held Aug07-09 in Rantoul.

Certification

• All teams except 9/11 have been certified as operational. Region 9/11 just recently received the Haz Mat equipment they have been lacking.

Radiation Detectors

ILEAS and IEMA have received 30 samples each from the four potential vendors. In June, ILEAS and IEMA staff trained officers from the WMD SRT teams throughout the state on how to use the sample detectors for the field trials. The decision as to which detector is selected will be based on pricing, training, support, laboratory bench tests and field trials. Hopefully, a decision will be made in October as to which detector will be selected.
