**Budget**

See the attached Budget sheets. As discussed in the July Board meeting, ILEAS is now in between budget steps 15 and 16. In the July meeting, the ILEAS Board passed a budget recommendation to the Terrorism Task Force. At their July meeting, the Task Force made minor modifications to the budget and adopted it. Since then, ITTF staff has been working with ILEAS staff to develop specific budget line items that fit into the modified budget. Grant agreements are being developed and will be signed yet this month.

In the State FY 07/08 budget passed by the general assembly this summer, the governor vetoed the ILEAS \$125,000 general revenue line item out of the IEMA budget. This is particularly significant because this fund is where ILEAS pays for its auditors (\$15,000), lawyers (\$5,000) and insurance (\$40,000+).

**Insurance**

Through Champaign County's self-insurance carrier, ILEAS has finally received a quote for liability insurance. Mt. Hawley Insurance is the underwriter for the \$2,000,000 in general liability coverage at an annual premium of \$21,170. Lloyds of London would be carrier for the \$1,000,000 in professional liability coverage for a premium of \$7,500. Lloyds is, of course, a top rated insurance underwriter and Mt. Hawley. If we accept this coverage, the total insurance coverage will be:

**Grants**

All of the thermal imagers have been distributed and the agencies have received training. The MSA thermal imagers were distributed and training conducted in July. The Bullard thermal imagers training and distribution was completed on September 5<sup>th</sup>. All but a handful of the MDC's have been distributed as well.

ITTF is waiting for Department of Homeland Security approval to develop an additional grant agreement for ILEAS for approximately \$140,000 in FY 04 funds from another source. ITTF staff requested that ILEAS submit a plan for the use of those funds. In response to a survey by ILEAS, we learned that several law enforcement agencies were promised funds from the State of Illinois but were vetoed by the Governor or otherwise fell victim to the State budget battles this summer. Many of the local agency projects would not be allowable under DHS guidance (i.e. squad cars), but some are eligible, fencing, cameras, MDC's, etc. We propose that ILEAS accept these funds from ITTF and apply as much of them as possible to the agencies in Illinois whose eligible projects were vetoed or cut. The remainder of the funds would be dedicated to remaining law enforcement StarCom21 radio requests.

Additionally, ILEAS has been asked to assist ITTF in the development of and management of the online Public Safety Interoperable Communications Grant (PSIC). This grant will be open to all public safety agencies in Illinois and will be open from October through the end of the year. Indilus is presently working with ITTF staff to develop the online system. Once it is up and running, ILEAS staff will assist applicants to ensure that they have fulfilled their application obligations.

### **Communications**

Dave Owens represents ILEAS on the State Interoperability Executive committee (SEIC) and has participated in numerous teleconference and meetings. Dave was asked to provide a written standard operating procedure for law enforcement as part of the statewide interoperability plan. SOP's for the various emergency service disciplines within the State of Illinois were required for their particular discipline as part of the statewide plan. This plan must be submitted as part of the PISC grant application which has been submitted and awarded to Illinois. Dave received assistance from Doug Edmonds in developing this plan.

This six page documents met the numerous requirements of the PISC grant and contains a lot of background information about the interoperability assets that are available to law enforcement agencies within Illinois. The statewide interoperability plan, once it is finalized, will be made available to all emergency service disciplines by various means. This plan will require additional review and modification after it has been exercised in training scenarios to better adapt it to realistic field operations. In the future this SOP will be modified to take advantage of field exercise experience and apply those things which were learned into the plan.

Dave Owens continues to work with Motorola and the individual ILEAS WMD SRT's to get their radios programmed with an up-date radio template. This work continues to move along slowly but progress is being made. I'm optimistic that we will finish this project within the next 30 to 60 days.

### **Gas Masks**

AVON FM12 respirator requests are continuously coming in to the ILEAS office. These are being organized and filed until we are able to fill them. Peoria Police Department returned 211 unused masks. Those have been redistributed to seven agencies around the East Central Illinois area. Monocles and carriers were ordered to make sure agencies are receiving a complete respirator package. These agencies have been notified their equipment is ready for pick up. Additionally, ILEAS staff receives calls from agencies that want to return unused masks. We try to find homes for all of that equipment. There are sufficient funds budgeted in FY 07 to purchase approximately 800 more masks.

### **Radios**

Only one VHF radio remains out of the 500 ILEAS purchased. Fifty-seven additional StarCom 21 radios have been purchased and distributed. A list of the remaining 31 agencies that have requested but not received StarCom21 radios has been sent to ITTF.

### **Inventory**

The 2008 inventory of the special teams has begun by Jennifer Ford. She personally visits each team and visually inspects all the equipment. Additional items that has been distributed is added to the online database.

### **Dues**

There are 17 agencies that have not paid their dues for 2006, 36 that have not paid for 2007 and 3 people have not paid their conference fees. We have contacted them all directly and sent notices and bills. I have attached the list to this report. Staff requests that the Regional Co-chairs contact the chiefs and sheriffs of these delinquent agencies in their regions and attempt to persuade them to pay.

### **Conference**

We already have several speakers scheduled for the conference which is scheduled for March 2-4, 2008. Most of the breakout sessions have been identified. Vendor letters are going out yet this month.

### Organizational Status

- A Mobile Field Force has been formed in the Southwest Suburban Chicago area based in Plainfield. No other area has shown significant interest in forming a mobile field force.
- Region 8 and NIPAS are fully operational

### Training

- NIPAS and Region 8 have completed their ILEAS Basic training. Region 3 North (Kane-McHenry is scheduled for Oct 08-10.
- A Less Lethal/Chemical Train the Trainer is scheduled for October 01-05 in Kankakee.

### Equipment

- The first 5 Mobile Field Force Trucks have been delivered and the additional 2 have been ordered.

## WMD Special Response Teams

## SWAT Basic

ILEAS, NIPAS and the NCBRT worked together to finalize the 80-hour SWAT Basic. As you may recall, ILEAS needs this SWAT Basic curriculum approved so we can continue to train new WMD SRT team members AND to develop a standard in Illinois for SWAT team training. ILEAS submitted the first version in early 2006 and it was rejected by DHS with comments and suggestions. Since that time, ILEAS and NIPAS requested that NCBRT assist with the development of this curriculum to DHS standards. they have recently completed that task. the curriculum has been submitted to the ITTF in order to pass it onto DHS for review. ILEAS has sponsored this training for the three allowable "pilot" classes and cannot use any more federal funds until it is approved. More to follow.

## Validation

NIPAS recently conducted a "pilot" validation training project. NCBRT and ILEAS are going to work with NIPAS staff to develop this WMD SRT validation process in the same manner as the SWAT Basic and submit it to DHS. Our hope is that, if approved, ILEAS can use DHS funds to validate all of our WMD SRT teams. since there is no validation process in existence nationally, if this gets approved, it may eventually be a process that ILEAS and NIPAS can conduct at the ILEAS Training Center under the auspices of NCBRT for teams from other states.

## **ILEAS Update and N95 fit Testing Workshops**

Two workshops were held in August and one final Fit Testing workshop is scheduled for October 17<sup>th</sup> in Fairview Heights. This should conclude these offerings. Any future ILEAS updates will be provided at the annual conference.

## **Active Shooter**

ILEAS is co-sponsoring an Advanced Law Enforcement Rapid Response Training (active shooter) in Urbana at the ILEAS Training Center on November 5-9, 2007. Additionally, the NCBRT has requested that ILEAS work with NIPAS and their staff to develop and pilot their version of active shooter called LASER. They are working to get it certified for DHS funds.

## **Campus Security Task Force**

As part of the campus security network the Illinois Terrorism Task Force (ITTF) and Motorola provided 303 Starcom21 portable radios to 70 Universities and Colleges. ILEAS staff contacted all the universities and colleges in Illinois develop a contact list and inquire if they wanted a radio. In order to receive the equipment, each school was required to attend a training session. These sessions provided instruction on the use of the StarCom 21 portable and was conducted by Stephen Jackson the Communications Officer for IEMA. Dave owens conducted training regarding the use of talk groups, suggestions for communications SOP's, an overview of the ITTF as well as an overview of the many statewide resources that could be made available to these schools in a case of an emergency. A Motorola representative also provided an overview of the Starcom21 radio network for them.

The first training session was conducted at the University of Illinois Chicago on Aug. 28<sup>th</sup> and the second session was conducted on Sept. 13<sup>th</sup> at the State Emergency Operation Center in Springfield. A modified version of the power point used for this training was posted on the ILEAS web site.

Dave attended his first full Campus Safety Task Force meeting on Sept. 20<sup>th</sup> in Springfield and is currently on the Preparedness and Response Committee.

## **Radiation Detectors**

On June 28th and 29th ILEAS began the Field Testing phase of the instrument selection process. Training was conducted for three of the four instruments (the fourth instrument was delayed due to technical difficulties). Each class was approximately four hours long and consisted of 18 officers randomly selected from various SRT teams and ISP Districts around the state.

On September 1<sup>st</sup> we ended the Field Testing phase for all but the final instrument (which was delayed in starting). We are in the process of collecting all the evaluation forms from the participating officers and tabulating the data. This data will then assist the committee in making their final decision as to which instrument to purchase. That decision should be made around the 1<sup>st</sup> of November and a purchase order entered by the end of the year. The committee is also in the process of evaluating Radiological Isotope Identifier Devices (RIID's) that will be used as part of the reach-back for unresolved alarms.

Two vital areas that the committees are working are the legal issues related to stop and investigations based upon the use of the PRDs and the infrastructure for the reach back for unresolved alarms. We will have to answer these questions prior to placing any instruments on the streets.

## **ILEAS Training Center**

Since the ILEAS Board approved this project in July, the following has occurred:

- The Champaign County Board unanimously approved the lease on August 23<sup>rd</sup>.
- ILEAS and Champaign County staff have been meeting with Isaksen, Glerum & Wachter, the architect, and GHR Engineers & Associates, the mechanical engineer. Note that these two firms were selected by and being paid by Champaign County.
- Final programmatic drawings are being developed at this time and should be completed next week.
- Meetings have started regarding the information technology and telecommunications infrastructure as well as security equipment.
- ILEAS provided IL-WARN and Carle Hospital with quotes for sub-lease offices and rental space.
- IMERT has offered to pay ILEAS \$30,000 for the next three years to store their trailers, vehicles and equipment at the ILEAS Training Center.
- ILEAS was contacted by the Center for Advanced BioEnergy Research (CABER) at the University of Illinois to participate with them and IFSI to host and sponsor a series of workshops on the public safety concerns of new alternative fuel sources (hydrogen, ethanol, etc.) and agro-terrorism.
- ILEAS staff has met with the Director, Assistant Director and others from the National Center for Biomedical Research and Training at Louisiana State University. They traveled to Urbana and toured the facility. Based on the trip and our discussions, they are developing a business proposal for ILEAS to host their training and possibly contract with them to provide equipment storage for their training equipment.
- ILEAS staff has met with a representative from the Counter-Terrorism Operations Support (CTOS – Dept. of Energy Nevada) to begin discussions regarding the radiation detector training.
- We have a meeting scheduled at the ILEAS Training Center with representatives from the Center for Domestic Preparedness (Anniston, AL) to begin contract negotiations with them to provide training and assistance with marketing in the 17 state Midwest region.

## **Illinois Telecommunicator Emergency Response Taskforce (ILTERT)**

ILEAS is assisting ILTERT in creating teams of highly qualified public safety telecommunicators. These teams will perform the following functions:

- Respond rapidly to the scene of disaster situations any place in the State of Illinois.
- Respond to disaster situations out-of-state under the EMAC compact.
- Provide assistance to other Illinois PSAP's that encounter crisis situations.
- Provide advice to agencies that wish to develop local Field Communications teams.

Currently, ILEAS has sent out a Request for Proposals to various vendors seeking a commercial public safety training company to provide workshops that will include the following information:

- Basic introduction to field communications/Roles of the dispatch in the field
- Field communications documentation/Tactical and incident communications

- NIMS and the role of communications
- Communications vehicle and mobile command centers
- Basic overview of specific Illinois resources
  - Unified Command Vehicles & ITECS Trailer

**ICASE**

ISP released the “beta” version (final test version running on the ‘live’ production hardware) of ICASE on June 25, 2007 to District Chicago, District 19 and Zone 1 Investigations to 20 total users. ISP is expanding its beta test group with the addition of District 9 Springfield, where training will begin the week of 9/24. Beta testers have successfully entered over 100 case classes, includes drugs, guns, death investigations, Article 36 seizures, and traffic. Supervisors are successfully approving or rejecting those reports – both in the connected LAN and ‘disconnected’ mobile environments. The beta test has validated that the ICASE application functions as expected in the mobile wireless environment, as well and on the LAN.

ICASE project was monitored and audited by the Illinois Office of Internal Audit (IOIA) as part of their FY07/08 Audit Plan. The Fiscal Control and Internal Auditing Act (FCIAA) mandates review of the design of major new electronic data processing systems and major modifications of those systems before their installation to ensure the systems provide for adequate audit trails and accountability. No major system problems were detected by the IOIA that would prevent ISP from implementing the ICASE system.

**ICLEAR**

The I-CLEAR Data Warehouse is still in beta testing, with 100+ users currently accessing the system. The beta version currently contains data from the CHRI (Criminal History Records) database. Recently, six million mug shots were loaded from the Chicago Police Department. This was an enormous success. Due to the nature of the data, beta users must be LEADS certified, and have completed the ICLEAR DW online training module.

Before, access to CHRI was limited to name and date-of-birth queries only. The I-CLEAR Data Warehouse allows users to query and analyze CHRI data in ways never before possible. For example, an investigator may know only the height, weight, and tattoo description of a home invasion suspect – through I-CLEAR, the investigator can query on any or all of these fields and potentially retrieve a suspect list. In addition, once the investigator finds his list of suspects, he can interactively map that information in order to compare their residence addresses to the address of the incident.

Chicago Police Department incident/case data is also being loaded into the I-CLEAR Data Warehouse. An iterative process, it is imperative to load the data accurately and completely. The screen needed to query case data (be it from CPD or other case data) is approximately 80 percent complete – including the interactive mapping component. As with ICASE, ISP is continuing to develop and fine-tune its DW Detailed Support Plan, Backup-Recovery Plan, Configuration Management Plan, and Disaster Recovery Plan. These support plans will expand and mature commensurate with ISP’s incremental deployment of both applications. Finally, ISP has completed version one of its ICLEAR Privacy Policy, a critical component of the ICLEAR program – one that helps ensure we reasonably and fairly address privacy and information quality concerns appropriate to the broad scale information sharing capability we are developing.

**Unified Command Post Vehicles**

After the first of the year Dave Owens is preparing to put together training scenarios for the Unified Command Post Vehicles so that they can train on the new Statewide Interoperable Radio Plan and to test the plan’s capabilities and to identify weaknesses.
