FY14 Grant Adjustments

As the Board is aware from the last meeting, ITTF changed the standard practice of extending the unspent parts of the FY14 grant from March 31st out to June 30th in order to pay ahead on salaries. At this time last year, ITTF had funds unspent by other agencies which were transferred to ILEAS. ILEAS used those funds to, among other things, pay ahead the next quarter of salaries. This practice provides a "cushion" for ILEAS staff during the following year. As a result, as we reach the end of the grant year on March 31st, ILEAS had one quarter of salaries and other unspent funds. However this year, ITTF would not allow us to pay ahead on salaries. As a result, the FY13 funds we received last year created a surplus of funds this year which has to be spent on equipment and not salaries. These funds were in excess of \$400,000.

The ILEAS Finance staff spent several weeks in negotiations with ITTF/IEMA staff about the disposition of those funds. The proposals for these funds were discussed at the last meeting in detail. The Board approved the staff moving ahead to work with ITTF/IEMA to acquire equipment and spend the money appropriately. The following is how that has worked out to date:

Requested Board Action

Staff requests that the Board:

- (1) Endorse the equipment acquisitions as presented
- (2) Purchase the shelter equipment as proposed if approved
- (3) If the shelter is not approved, work with ITTF under the supervision of the Executive Officers to appropriately invest the \$216,000

FY16 Grant Applications

Every year ITTF establishes a new or changed process for applying for Federal Homeland Security Grant Program funds. Usually there is a period of budget proposals and discussions which are considered and recommended by ITTF in a following meeting. As of this writing, we are told that this year will be different in that there will only be one budget discussion meeting (March 23rd). The grant applications had to be completed and submitted on March 14th.

I want to pause for a moment to praise Larry Evans, Jan Plotner, Tiffany McElroy-Smetzer as swell as the rest of the finance staff who have been working overtime to prepare this budget proposal – not a small task – while at the same time dealing with the last minute "curve balls" regarding the FY14 grant surplus funds as well as preparing for the Conference registration to open on March 17th. They deserve our appreciation for a significant amount of well done, professional work in the last month. After having participated in and observed the financial process for all of the ITTF committees for the last 12 years, that the ILEAS finance staff is simply the best – bar none.

This is what ILEAS submitted for grant applications for the time period covered by FY16 (April 1, 2017 thru June 30, 2018). For line item details, see the attached budget detail worksheets in the financial packet. These tables reflect summaries:

There are no new programs being proposed in FY16 as virtually everything is a continuation of FY15. The only item of note is approximately \$31,000 for Critical Incident Management Training and Exercises for the regional law enforcement incident management teams that are being built based on the DuPage LE-IMT model. ILEAS has received interest from officials in Lake, Will and the METRO East areas wanting to consider creating teams. As a pilot project, ILEAS funded the basic training for the DuPage team which has been very successful. This budget supports the same arrangement where ILEAS pays the instructors for the basic training and all other costs are borne by the local agencies.

Requested Board Action

Staff is requesting that the Board:

- 1. approve/endorse the grant applications as presented
- 2. authorize the staff to complete the grant paperwork once a decision by IEMA on specific amounts has been determined

Once that process is complete, the staff will present final versions of the FY16 grants to the Board at the June Conference Board meeting.

Purchasing Policy Change

The current ILEAS Purchasing Policy provides that ILEAS can make purchases pursuant to GSA and Illinois Master Contracts and approved vendors. This ensures that due diligence has been done with regard to regulatory requirements and processes. It also most often allows ILEAS to get better pricing.

At this point, ILEAS is updating and modernizing all the financial policies to ready for the next sub-recipient monitoring visit by the State. Prior to that, staff would request that the Board authorize a third option in the Purchasing Policy to add to the GSA and State vendor lists. That option is participating in the U.S. Communities – A Government Purchasing Alliance (www.uscommunities.org). It was founded by the Association of School Business Officials, the National Association of Counties, the National League of Cities and the United States Conference of Mayors as a means of pooling resources, contracts and locating vendors for government purchasing. It is a leading solution for public agency purchasing, procurement and solutions. Membership in this alliance is limited to public agencies. In Illinois, there are 728 cities, villages and special district members, 234 counties and county-run agencies, 1,148 K-12 school districts, 127 universities and colleges (including all the State universities), 55 State agencies (including the State Police, Admin. Office of the Courts, IDOT, Military Affairs, Corrections, CMS, Auditor General, etc.), and 177 townships and libraries. The City of Chicago is a "lead" public agency in U.S. Communities. There are a total of 55,000 public agency members in the Alliance nationwide.

In order to provide more options, get better pricing and to ensure that due diligence has been done with regard to regulatory requirements, staff recommends that ILEAS join U.S. Communities.

Requested Board Action

Staff is requesting that the Board authorize the staff to join U.S. Communities and the amend the purchasing policy to reflect the addition as an option for purchasing.

FEMA/DHS Information Bulletin IB-407

Recently, FEMA adopted Information Bulletin #407 to all homeland security grant recipients. This new policy significantly restricts what can be purchased with Federal grant dollars. The following equipment cannot be purchased whatsoever and are considered prohibited:

Tracked Armored Vehicles Grenade Launchers

Weaponized Vehicles, Watercraft or Aircraft Bayonets

Firearms & Ammunition .50 Caliber or higher Camouflage uniforms Used for Urban Settings

The following equipment is now considered Controlled Equipment:

Fixed & Winged Manned Aircraft Firearms and Ammunition Under .50 Caliber*

Unmanned Aerial Vehicles Explosives and Pyrotechnics

Wheeled Armored & Tactical Vehicles Breaching Apparatus

Command and Control Vehicles Riot Batons,

Helmets & Shields*

Note that previously, FEMA prohibited personal protective gear that officers use during riot situations – padding, shin and knee protectors, arm guards, etc. Please also note that all of these rules apply to law enforcement, FEMA is enforcing this for all disciplines receiving Federal money. The new procedure requires that if a law enforcement grantee (including ILEAS) wants to spend grant money on any of the allowable controlled equipment, there is significant bureaucracy, including:

- Submission of a detailed form requesting permission to purchase the controlled equipment, FF-087-0-0-1 to FEMA through the State for review.
- Development and implementation as well as retention of documents of polices that govern
 - 1) the appropriate use of the equipment,
 - 2) supervision of the equipment,
 - o 3) effectiveness evaluations,
 - o 4) auditing and accountability, and
 - o 5) transparency
- Any agency using the equipment (not limited to just the owners or purchasers) must submit written policies governing:
 - Community Policing Policy
 - Constitutional Policing Policy
 - Community Input and Impact Considerations
- Training Requirements to include:
 - Technical Proficiency
 - Scenario-based training
 - Training on civil Rights and Liberties
- Significant Detailed After Action Report Requirements
- Compliance with 2 CFR Part 200 with regard to Disposition, Transfer and other Requirements

Violations of IB-407 will be investigated not by FEMA, but by the Office of Civil Rights at the Department of Justice.

This Bulletin is for any expenditure of money from a grant issued after October 1, 2015. Therefore, it will apply to the FY16 budget. This significantly affects Mobile Field Force. Basically this Administration does not want the police to use Federal money to equip riot-response capabilities. Please note that this applies to our Mobile Field Force equipment trucks, Bearcats, and other tactical vehicles.

An important aspect of IB-407 ----- These rules apply to every agency that is part of a mutual aid agreement, not just the agency that buys or keeps the equipment. In order for ILEAS to purchase anything on the controlled list, we would have to collect those policies and paperwork for training, etc. from all 940 agencies in our network.

Staff has interacted with FEMA in a webinar, been back and forth with IEMA and discussed this internally at length. We have come to the conclusion that the best way to respond to this Bulletin is to avoid purchasing anything on the Controlled List thereby avoiding all the bureaucracy required by it.

Requested Board Action

If the Board agrees, staff recommends adopting the policy of avoiding Controlled List equipment acquisitions.

Communications Program Update

At the last Governing Board meeting, the Board indicated that the staff should continue to develop a communications plan and present it to ITTF/IEMA and the Governing Board at this meeting. the result of that work is a report entitled "Interoperable Communications and Technology Support Restructuring Proposal." A copy has been included in the Board packet.

The staff reviewed the communications after action reports of large exercises and actual events going back a few years. They compiled the gaps that needed addressed and identified the strength that needed built upon. That review was compared to the actual budget for FY15 (which starts next week) and a plan was developed. This plan has been reviewed and approved by Director James Joseph, Chief Executive Officer of MABAS, jay Reardon, as well as Dan Fulscher and Dave Christensen, the co-chairs of the ITTF Emergency Management Committee. Additionally, it has been presented to the ITTF Communications and Technology Committee. To date, with minor considerations, this plan has been endorsed by all of those organizations and people. Jim Page also spoke with Col. Tad Williams and others with the Illinois State Police. ISP and ILEAS agreed that ISP should be part of the Technology Support Teams (already in the plan) and that consideration be given during the planning of the caches that consideration be given to the storage of some of the cache radios at the Districts. After Board approval, those specific discussions will begin to take place.

So that this plan can start to be implemented, staff is requesting that the ILEAS Governing Board officially endorse the plan. Other than the StarCom21 user fees having already been authorized and payment being made, there are no budget items that require Board approval at this time.

What has been done to date:

- the Starcom21 user fees have been billed and are being paid
- the process of identifying what 200 agencies will retain their individual user licenses is nearing completion
- a letter from IEMA to agencies holding the radios has been written and will be mailed out within a week,
- both ILEAS and IEMA inspectors audited the radio equipment being stored at the Wauconda Fire Department and transported to ILEAS a large amount of that equipment for inventory and inspection.

It should be noted that a significant amount of cache radios were left at Wauconda as well as those assigned to their Unified Command Post. ILEAS staff combined the Wauconda cache with the VHF radios returned to ILEAS last fall and the StarCom21 radios that were surrendered to ILEAS during the most recent rounds of rebanding. This replacement cost of this amount of communications equipment is well over \$1 million. ILEAS had to increase its property coverage in order to insure that amount of equipment all in one place. The intent is to distribute those radios across the state to ITECS, regional caches and to the soon-to-be-created Technology Support Teams.

What needs to be done next:

- Mail the letter to the agencies that will no longer have their StarCom21 radio fees paid by ITTF/IEMA.
- Develop and implement a "return/surrender" radio protocol
- Engage the services of a contractor to do a comprehensive assessment of the current inventory and capabilities and provide a recommendation about capital replacement, equipment needs and any gaps in communications that needs to be filled
- Being the development of the Regional Technology Support Teams.

It should be noted that every agency losing their user fee support will be given two options, 1) keep the radio as their own and pay the user fee directly to Motorola, or 2) surrender/return the radio to ILEAS. A protocol for returns is being developed and will include a combination of shipping, collection points and pickups. ILEAS is working with other communications groups to develop a plan for those radios that are returned – which could theoretically be in the hundreds. Our initial thoughts were:

- to implement a grant program for agencies that want to convert to StarCom21 that can pay the user fees but cannot afford the radios.
- Current StarCom21 subscriber agencies that want to add to their fleet.
- Swap out any radios from the current caches with unused radios from those returned (unused radios to replace used ones)
- Trade remaining stock to Motorola for equipment that is not funded

Requested Board Action

Staff requests that the Board endorse the Communications Plan as presented and direct staff to begin the implementation.

Legislative Update

An update on ILEAS proposed legislation is as follows.

Making the Homeland Security Emergency Preparedness Trust Fund a "Continuing Appropriation"

Bill #: HB6042

Sponsor: Rep. Donald Moffitt (R – Galesburg)

Status: Held in Rules Committee

ILEAS proposed the modification below to the enabling statute which created the Homeland Security Emergency Preparedness Trust Fund to make that Fund a "continuing appropriation." This Fund consists only of Federal grant money and NO State money.

(20 ILCS 3305/17.5)

Sec. 17.5. Homeland Security Emergency Preparedness Fund. The Homeland Security Emergency Preparedness Trust Fund is created as a federal trust fund in the State treasury. The Trust Fund shall be held separate and apart from all public moneys or funds of this State. All Homeland Security moneys received by the Agency under Section 17 from a federal department or agency shall be deposited into the Trust Fund. Interest earned by the investment or deposit of moneys accumulated in the Trust Fund shall be deposited into the Trust Fund. The Trust Fund shall be considered always appropriated for the purposes of disbursements, as provided in this Section, and shall be paid out and disbursed only as provided herein, and shall not, at any time be appropriated or diverted to any other use or purpose. The Agency is authorized to expend any moneys in the Trust Fund for the specific purposes established by the terms and conditions of the federal awards received by the Agency and in any amount that the Agency deems necessary to make grants and pay expenses in connection with its emergency management and preparedness programs.

ILEAS, MABAS and Emergency Management Funding

Sponsor: Rep's Donald Moffitt (R – Galesburg), Elaine Nekritz (D-Buffalo Grove), Robert Pritchard

(R-Sycamore)

Status: First Reading then assigned to be held in Rules Committee

Bill #: SB2592

Sponsor: Senator Pamela Althoff (R-McHenry), Senator Anthony Munoz (D-Chicago)

Status: Assigned to the State Government and Veterans Affairs Committee – Postponed

There are two identical companion bills – one in the Senate and one in the House. This is the same language as last year. The Chiefs' and the Sheriffs' Association have been notified and support the bills. At this time, there are two official opponents – the Secretary of State and the Transportation for Illinois Coalition (TIC). The

TIC consists of the Illinois Chamber of Commerce, General contractors, Asphalt Pavement Association, Coal Association, Construction Industry Council, etc. etc. Their objection is as follows:

"There are two sources of revenue for highway and road funding in Illinois — the motor fuel tax and the motor vehicle registration or license plate fee. Both sources have been stagnant or declining over the past several years, while the costs of construction have increased considerably. The state of our transportation infrastructure is declining and the coalition and policymakers look to those two revenues sources (known as user fees because they are paid by the people who use the system and are used for maintenance and upkeep of the system) when considering an increase in funding to try to keep up with the maintenance of our current roads, bridges, etc.

When others try to increase highway user fees for non-user purposes, that makes increases for the intended purpose (transportation construction) less likely and necessarily smaller because taxpayers can only tolerate so much. Further, the compact with voters — that these user fees are used for the purpose for which they were originally enacted — is damaged and voter support for transportation revenue increases lessens because taxpayers are concerned that the money won't go for the purpose they believe it is intended for.

Having said all of that, if you would like to have your client make the case from your perspective in a meeting with the TFIC Statehouse Committee, we can arrange that by working with you both. I think Pam has some thoughts in that regard."

A meeting date between ILEAS and TIC has been set up for April 4th in Springfield. More to follow after that meeting.

(20 ILCS 3305/25 new)

Sec. 25. Homeland security preparedness.

- (a) There is hereby created the Homeland Security Preparedness Fund as a special fund in the State treasury.
- (b) The Illinois Emergency Management Agency shall establish guidelines by rule for the expenditure of the funds in the Homeland Security Preparedness Fund with input provided by a statewide interagency organization and public safety multidisciplinary organizations established to advise the Director of the Illinois Emergency Management Agency regarding public safety preparedness.
- (c) Following the guidelines established under subsection (b) of this Section, the Illinois Emergency Management Agency shall spend the moneys in the fund to enhance State and local homeland security preparedness, all risk disaster response readiness, and statewide public safety mutual aid.
- (d) The use of all funds shall be limited to statewide mutual aid based systems, interoperable communications systems and networks, initiatives and programs designed for statewide emergency incident planning, prevention, and response.
- (e) Funds shall be distributed among the programs as follows:
- (1) for statewide law enforcement mutual aid: 33%;
- (2) for fire protection mutual aid: 33%; and
- (3) for other statewide preparedness projects, programs, and efforts as determined by the Illinois Emergency Management Agency: 34%. The statewide preparedness projects, programs, and efforts under paragraph (3) of subsection (e) include, but are not limited to, state preparedness systems concerning terrorism intelligence, protection and preventive programs, and statewide public safety training programs, funds spent for Cook county and the city of Chicago, and local emergency management agencies.
- (f) Moneys in the Homeland Security Preparedness Fund shall be transferred each month to the Illinois Emergency Management Agency for redistribution to the appropriate organizations.

(625 ILCS 5/3-806) Registration Fees

Beginning with the 2015 registration year, a \$3 surcharge shall be collected in addition to the above fees for motor vehicles of the first division, motorcycles, motor driven cycles, and pedalcycles to be deposited into the Homeland Security Preparedness Fund for the Illinois Emergency Management Agency to use as directed under Section 25 of the Illinois Emergency Management Agency Act. This surcharge shall not apply to registration of vehicles by units of local, State, or federal government and organizations based in this State that meet the requirements of Title 26, Section 501 (c)(3) of the United States Code.

Drones

The language ILEAS proposed modifies the Freedom From Drone Surveillance Act to account for the use of a drone during training.

Bill #: SB2588

Sponsor: Senator Anthony Munoz (D-Chicago)

Status: Assigned to the Criminal Law Committee – Postponed

This bill has drawn some opposition as well. To date, official opposition has been noted from the ACLU, an organization called the Friends of the Parks and one police officer. John Millner and Jim Page have been back and forth with the ACLU. They are opposed in principle to drone use by law enforcement and want to restrict them as much as possible. They made a language amendment that was not practical and for all intents and purposes prohibited law enforcement from using the drones during training. However, after some discussion, they agreed in principle to a change in language that, as of this writing, they are reviewing. Millner believes that if we can get an agreement with the ACLU on compromise language, they bill should have no real problem getting adopted.

This was the original pertinent language as proposed and is currently before the Committee:

(1) If a law enforcement agency is using a drone solely for law enforcement training purposes. Training must be conducted in a geographically confined and time-limited manner that will safeguard the privacy of individuals. The use of a drone under this paragraph (7) on private property requires lawful consent. The use of a drone under this paragraph (7) on lands, highways, roadways, or areas belonging to this State or political subdivisions of this State does not require a search warrant or consent to search. Any law enforcement agency operating a drone under this paragraph (7) shall make every reasonable attempt to only photograph the law enforcement training and avoid other areas or individuals.

This is the amended pertinent language for subsection 1 that has been proposed to the ACLU:

- 1) If a law enforcement agency is using a drone solely for law enforcement training purposes. Training must be conducted in a geographically confined and time-limited manner that will safeguard the privacy of individuals.
 - a. The use of a drone under this paragraph (7) on private property requires lawful consent.
 - b. The use of a drone under this paragraph (7) on lands, highways, roadways, or areas belonging to this State or political subdivisions of this State does not require a search warrant or consent to search. requires law enforcement to make reasonable efforts to notify the public and restrict their presence for the duration of the training.
 - c. The use of a drone under this paragraph (7) may take place at established law enforcement and public safety training facilities
 - d. Any law enforcement agency operating a drone under this paragraph (7) shall make every reasonable attempt to only photograph the law enforcement training and avoid other areas or individuals.
 - e. Information collected from a drone used by law enforcement for training purposes shall be deleted as soon as no longer required for training purposes.

As of this writing, we are awaiting their input and/or agreement.

Requested Board Action

Staff requests that the Board continue its authorization moving forward with these proposed bills under the supervision of the Executive Officers.

Region 4 North Mobile Field Force Team

At the previous meeting, the Board authorized the establishment of a new Mobile Field Force team in Region 4 to cover the areas of Central and Northern Cook, Lake and DuPage counties. This Region 4 North Mobile Field Force team will be based on Cook County as a significant amount of funds to purchase the equipment are UASI funds which must be invested to benefit Cook county directly. The Board also voted to finalize the arrangement with the NIPAS Mobile Field Force leaving the equipment with that team conditioned on the adoption of a mutually agreed upon MOU. Jim Page spoke with NIPAS President Clint Herdegen and informed him of the Board's decision. Chief Herdegen was not surprised and while he wished it could have

been worked out differently, he understood. He was appreciative of the Board leaving the equipment with NIPAS. However, he was worried that agencies would leave the NIPAS Mobile Field Force to join the ILEAS team. He was assured that ILEAS would not recruit NIPAS Mobile Field Force agencies for the new team and would notify him of any NIPAS agencies wanting to move.

On March 3rd ILEAS received a UASI grant for \$218,790.73 to purchase the two vehicles for the Region 4 North Mobile Field Force. This grant was unused from its original purpose by ITTF which is now nearing expiration. ILEAS has a purchase order to the vendor with an expected delivery date at the end of July.

The path forward is:

- 1. Receive the Final FY15 UASI funds to fund the Region 4 South Mobile Field Force, the Region 4 North Mobile Field Force and the NIPAS WMD Special Response Team.
- 2. Meet with the Region 4 South leadership and discuss expanding its boundary in Cook County north.
- 3. Announce to non-NIPAS agencies in DuPage, Central/Northern Cook and Lake counties the formation of the Region 4 North Mobile Field Force team.
- 4. Identify a host agency for the equipment inside Cook County
- 5. Identify a governing/oversight group
- 6. Identify a Team Commander
- 7. Begin Team member selection, equipping and training
