901 agencies are now members of ILEAS.

501c3 Status

As the Board is aware, the ILEAS Foundation has been created. The 501c3 application went into the IRS in November. The IRS responded to ILEAS with a requested change in the Foundation By-laws. The change required the Foundation to donate all of its assets to another 501c3 organization if it ever went out of business. Our attorneys made that change and all the Foundation officers have signed off on the required forms. The reviewer at the IRS stated that they would probably send the approval documents mid-summer.

Radiation Detectors – Swails

Nearly 300 personal radiation detectors have now been deployed into the field as part of a pilot program led by IEMA. The areas of the pilot study include the I-70 corridor, Sangamon County, and Champaign County. IEMA has conducted numerous training classes for those participating for the pilot study. The purpose of this study is to evaluate the number of alarms and the strain that will place on the alarm response protocols (known as the “reachback”). Once IEMA feels their reachback protocols are sufficient to sustain the full distribution, the plan is to start distributing the remaining 6,000 instruments by the end of the year. It will likely several months to distribute all of the detectors due to the IEMA training requirements.

Pete Smith, Mark Griffeth and Ken Swails have all completed the PRD training.

ICLEAR – Swails

The ICLEAR project has made some significant strides forward. The data warehouse has been built and the next major step is to build a user interface and search mechanism for law enforcement officers (also known as the ICLEAR Analytics). To achieve the best possible product, ILEAS and ISP published an open request for proposals. After a rigorous review process, including a user evaluation by law enforcement officers from multiple agencies, Oracle was selected as the winning vendor. ILEAS immediately entered contract negotiations with Oracle, signing an agreement on April 29th. It is anticipated that this analytics applications will be built, installed, tested, and operational by early next year.

Credentialing – Swails

The secure credentialing program is gaining momentum. Several hundred credentials have been issued to date, with plans to issue several thousand more in the coming months. There are efforts in way to reach out to other entities in the commercial sector and incorporate them into the same secure credentialing system. Since this project was started several years ago, ILEAS and the State of Illinois has become one of the leading states in the area of FIPS 201 secure credentials. Our credentialing project has drawn national interest. On May 21, 2009 there was a national demonstration of the secure credentialing systems in which Illinois participated.

LMS – Swails

The Learning Management System (LMS) is another project being managed by ISP. The purpose of the LMS is to provide a central resource for web-based training, as well as a central database to assist agencies monitor their officer’s training and certifications. It has now has gone live. They are initially testing the system with 8 agencies and anticipate expanding this with another 25 agencies before the end of the summer. To date there have been no major complications and the LMS appears to be operating as planned.

Communications – Owens, Regan

SIEC (Statewide Interoperability Executive Committee) –Owens

The SIEC has finalized the SCIP document and is currently available on the State of Illinois web site for review by local agencies. The SIEC is also putting out grants to High Population Counties within the State of Illinois to help finance their development of TICP's (Tactical Interpretable Communications Plans).

WMD SRT Communications - Regan, Owens

Dave Owens and Jeff Regan have worked to assist the WMD SRT's with their communications needs. Jeff has gotten all the SRT radios rebanded except for Region 9/11. Dave Owens assists teams with frequency and operational questions. He assisted NIPAS with an operation in Skokie earlier in May.

Communications Committees Meetings – Owens, Smith

Dave attends the STARCOM21 Monthly Project Team Meeting and ITTF Monthly Communication teleconferences/meetings. Pete Smith attended a MABAS Communications committee meeting as well.

Nextel Rebanding – Regan

Rebanding is nearly complete. ILEAS has rebanded 2,018 StarCom21 radios. There are 21 agencies that have NOT rebanded their radios. The ITTF policy is that these agencies should forfeit the radios back to ITTF for redistribution. Jeff Regan is finishing up the rebanding of all hardwired and portable Starcom21 equipment. He has done 24 remote site rebanding sessions (with valuable assistance from Dave Owens and Pete Smith). This included ITEC's Trailers, Mobile Command Posts, armored vehicles and consolettes. He has overseen the rebanding of hardwired radios in an additional 20+ locations by Motorola Field technicians. Jeff participates regular Motorola, CMS and ILEAS teleconference. Additionally, ILEAS has completed warranty work on over 600 VHF radios. To date, ILEAS has paid \$233,717 in reimbursements to agencies. ILEAS has also received \$20,500 net over expenses for the management oversight of the project.

CMS Communications Conference – Regan, Jones, Ford, Williams

ILEAS assisted Illinois Central Management Services sponsoring the "Bridging the Communications Gap" Conference in Springfield on May 11th and 12th. It was attended by over 200 participants and 15 vendors. By all accounts it was highly successful. ILEAS assisted CMS with online registration, vendor management and financials. The final financial account has not been completed; however, ILEAS will receive over \$1,000 for its part in assisting CMS. It was also attended by Dave Owens and Danielle Eades.

Internal ILEAS Policy – Regan

Jeff Regan drafted ILEAS internal communication policy for the use of StarCom21 radio equipment by staff and contractors. Once it has completed internal reviews, it will be presented to the Board for adoption.

Mobile Field Force Teams – Luecking

Organizational Status

- All mobile field forces are fully functional. Springfield PD added 25 officers to the Region 6 team to bring them to full staff.
- There is a proposal to increase the size of Region 2, 6 and 8/9/11 MFF's by 20 members to help some under served parts of the state.
- There is also a proposal to increase the role of the MFF's to assist the SRT's with perimeter security and decon operations. At the last team leader's meeting all present supported the proposal.

Training

- A MFF Basic course was held in Springfield May 12-14 for new and replacement team members.
- The three Region 3 teams held a joint training May 14. They also included the LEAC helicopter in the training.

Deployment

Reimbursement for the deployment to the RNC was submitted to St. Paul PD in October. Reimbursement was finally received in January and has been paid.

Assessment Exercise

We are in the planning stages of doing assessment exercises similar to that already in progress with the SRT's. We hope to have the first one done in the fall.

ILEAS has sent two mobile field force instructors to Denver for the Democratic National Convention, St. Paul for the Republican National Convention. Most recently they traveled to South bend, Indiana at the request of Notre Dame officials for advice on mobile field force responses in preparation for the President Obama visit.

WMD Special Response Teams - Luecking

Organizational Status:

Jody O'Guinn, team leader of the Region 8 SRT has resigned from his position. He is retiring from Alton PD and has taken the Chief's job at Carbondale PD. Michael Gordon from Alton PD will be taking his place as team leader.

Equipment

- Three Air Support Trucks (Alton, Springfield NIPAS) and the eight response vehicles have been delivered.
- We are in the process of preparing a priority list of equipment purchases from the following:

Training

Basic SWAT course will be held May 25-June 03 in Libertyville will have 37 students.

SRT Competency Assessment:

Assessment Exercises held for Region 2, Region 4, Region 6 and Region 6/7. All teams passed. We did identify areas of improvement and each team developed an improvement plan to work on those. The remaining exercises will start in late fall or early next year.

Equipment Displays – Owens, Regan

ILEAS has participated in one equipment display at the Capitol Building on May 6th and will participate in another at the Capitol on May 26th. The first display was a combined display of the CMS Law Enforcement Support Office (CMS LESO) and ILEAS. The second display is being conducted by ITTF. In both instances, ILEAS had one of each of the vehicles and high end equipment that has been purchased and distributed. Springfield PD, Winnebago County, McLean County and Rock Island County all assisted ILEAS by providing their vehicles and staff.

Illinois Department of Public Health (IDPH) Water – Young

Last summer the IDPH asked ILEAS to store 80 pallets (90,000 bottles) of bottled water that was remaining from the Flood Fight operations in early summer. ILEAS found donated warehouse space at two locations in Urbana where it was stored through the winter. The intention was to hold the water in case there was another disaster. In early spring, it was discovered by ILEAS staff that the water expired on June 15, 2009. Rather than discard 90,000 bottles of expired water, ILEAS worked with IEMA and IDPH to donate it to charity. On April 11, 2009 the inaugural Illinois Marathon was run in Champaign/Urbana. Over 9,000 runners from all over the world and tens of thousands of volunteers and people watching were also in attendance.

ILEAS donated the water to the race sponsors. In exchange, IEMA and ILEAS were able to place promotional literature in the runners' packets. It was a win-win for both the race and IEMA/IDPH/ILEAS. ILEAS handed out thousands of flyers about the Training Center being available for lease and IEMA distributed an equally large number of pamphlets about the READY.Illinois website.

As a result of ILEAS' willingness to assist IDPH, it is purchasing \$4,000 worth of pallet rack for ILEAS storage areas.

State Emergency Operations Center (SEOC) – Regan, Owens, Smith

ILEAS has been invited to participate in the SEOC operations when it is activated. Jeff Regan, Dave Owens and Pete Smith have been identified as the ILEAS SEOC Liaisons. Since he lives in Springfield, Jeff is the primary. He and Pete Smith have completed the SEOC Groove training and attend the monthly SEOC briefings/training sessions. Jeff staffed the ILEAS SEOC position during the initial H1N1 swine flue outbreak. He also provided staff assistance for the Southern Illinois Storm disaster. This is a program that is still being built, but it affords ILEAS the opportunity to participate in regional and statewide events.

Additionally, Mark Griffith, Danielle Eades and Jeff Regan are attending Emergency Mutual Aid Compact (EMAC) Field Course training on June 1st and 2nd. There is follow on EMAC A-team training on July 6-7, 2009. More to follow on this as it occurs.

ILEAS Training Center – Watson, Ford, Young (and everyone else really)

The ITC has been very busy. Please see the attached list of training that has occurred and is scheduled. There have been 88 training, workshops and significant meetings that have taken place to date that resulted in nearly 2,000 people attending the Center. There are another 55 sessions already scheduled for the rest of this year with more being added every week.

Some examples:

- A Tactical Emergency Medical Support summit was held at the ITC that included physicians, tactical team commanders and other medical representatives from all over the country.
- Illinois Tactical Officers Association (ITOA) Patrol Tactics class – Over 65 officers attended this training from all over the State
- The Bulletproof Mind – Col. Dave Grossman did a day-long presentation to over 110 officers
- The Illinois Medical Emergency Response Team (IMERT) – IMERT regularly conducts training at the ITC. Two weeks ago, IMERT had over 60 of their team members at the ITC on a weekend conducting a full scale exercise.

Michele Watson attended the Illinois Drug Enforcement Officers Association (IDEOA) conference in early April in Peoria. While there she met with Mark Peyton who is not only involved with IDEOA but also the Illinois MEG and Task Force Directors. The result of that meeting is that ILEAS is now hosting a two-week Midwest Counterdrug Training Center (MCTC) Basic Narcotics Course in November from the 2nd through the 13th at the ITC. If this goes well, they also provide a Lab Certification and Criminal Patrol for Rural Officers classes. The Basic Narcotics Officer class is being coordinated through the US. Attorney's Office – Terry Lucas. The IDEOA will be paying ILEAS for the facility for two weeks.

The bottom line is that the ITC is just now reaching its first anniversary and it has already experienced thousands of hours of high-level training. Additionally, ILEAS staff and Champaign County have been able to reach an agreement on a lease extension. ILEAS now has the facility locked in for an additional year without utility payments.

Inventory – Regan, Ford

The self-certification inventory is underway. The Field Inspectors will be brought on June 1 and work through July 31st. We encourage every agency to sign on and certify their inventory. This responsibility is being moved from Jennifer Ford to Jeff Regan.

IESMA – Eades

Staff

Danielle Eades is now responsible for the administration of all IESMA grants. The transfer from Jeff Regan to Danielle has been completed. She is responsible for all grant management and purchasing. This involves two different PO systems. The FY07 grants were still the responsibility of IESMA and the grants are processed under their previous system. The FY08 grants belong to ILEAS – which, of course, is under the ILEAS PO system. Until the FY07 grants are spent, she will have to monitor two financial systems. For example, the SAFE SCHOOL FY07 grant has closed and is now moved to FY08

Conferences

The IESMA Conference was held in Decatur from April 15th through the 18th. Danielle attended and assisted in the management of the conference. It was attended by 200+ people. Danielle conducted a breakout session regarding ILEAS and its current programs and how ILEAS is assisting IESMA with its grant management. ILEAS, along with the IESMA Conference Committee, will be responsible for determining a site for next year's conference.

Membership Database

Danielle and IESMA Treasurer Nancy Shilling have built a reasonably accurate IESMA membership database.

IMAT

ILEAS continues to support the IMAT team with regard to financials and logistics (hotels, meals, etc.)

Regional Operational Issues – Smith

Regional Catastrophic Planning Team – Smith

Pete Smith has attended a series of meetings of the Regional Catastrophic Planning Team, which has been formed to plan for the evacuation of the Chicago Metropolitan area. This includes Chicago, 10 Illinois counties, one in Wisconsin, and five in Northwest Indiana. The project is being funded by DHS, Chicago and Cook County in the amount of \$8 million. This plan will not only cover the evacuation of Chicago, but will address what to do with the evacuees when they reach or pass through the outlying areas. It will also cover evacuation of the other counties in the region in the event of a disaster there. Consultants have been hired to do the bulk of the work with eleven subcommittees of subject matter experts overseeing their efforts in the various areas of study. Pete is on the Intergovernmental and the Logistics subcommittees. The end result will be a regional plan which identifies gaps which need to be addressed. It's anticipated that funding will be available to address these issues later.

Solheim Cup – Smith

Pete also represented ILEAS at the request of the Kane County Sheriff's office for the Solheim Cup LPGA tournament in August of 2009 – the women's golf equivalent of the Ryder Cup. The Solheim is a large international event being held in Sugar Grove, Illinois. It is possible that heads of state and the international media will be present. Pete has been attending a series of planning meetings for this event as it relates to mutual aid and resources. He will also be actively involved in the JOC during the event.

Argonne – Smith

Met with Argonne staff regarding a project they want to conduct with the Illinois State Police and ILEAS. It involves predictive traffic software and an exercise that Argonne wants to conduct. More to follow on this as it develops.

Finance Manager - Huston

ILEAS has hired a new Finance Manager contractor. His name is Richard "Dick" Huston. He was formerly the assistant city comptroller in Aurora and the City Treasurer of Yorkville. He is a certified public accountant (CPA) and has many years of government grant and finance experience. He has met with the ILEAS auditor, Don Bennett and the ITTF finance/grant staff.

Dick has spent most of his time learning the purchase order and QuickBooks system as well as the grant and grant guidance rules. He has recently assumed the responsibility of approving all purchase orders. He has made several suggestions that will improve ILEAS fiscal processes and conditions. Once implemented, ILEAS will be operating at accounting industry standards.

A summary of his issues outlined in a report he submitted at the end of April:

- ILEAS needs to develop a system ensuring that transactions generated by our purchase order system are recorded and reconciled with our general ledger.
- The modified accrual system of accounting should be adopted for use on an ongoing basis.
- Monthly financial reports should be prepared.
- A formal budget should be adopted by the Board, and budget comparison reports should be prepared monthly. Budget amendments should be prepared when warranted.

- Collateralization of bank accounts should be adopted, since our balances consistently exceed FDIC limits (a plan currently in review would secure our fund balances through an FDIC program until at least 12/31/2009).
- Unencumbered grant balances should be reconciled with IEMA/ITTF
- Cash disbursements (check issuance) should be accomplished in house at ILEAS headquarters. Checks should be co-signed by the Executive Director and Finance Manager after preparation by the Staff Accountant. An additional signer should be available as a contingency.
- More efficient methods of receiving, tracking and storing paper work should be developed.
- The current use of debit cards for small purchases should be replaced by a Purchasing Credit Card Program, providing greater convenience and accountability.
- A formal purchasing procedure manual should be prepared based on the principles outlined in our current Purchasing Policy.

The Board will be asked to adopt a resolution adopting new procedures for check signing and credit cards. More will follow on this as these procedures are implemented.

NIMS – Griffeth, Smith

ILEAS continues to work with agencies to assist them in completing the required NIMS activities. This involves ensuring:

- Agencies are working within their jurisdiction to complete the task. They must have a single point of contact for NIMS in their village, city, or county.
- The point of contact must reach out to Deb Watts at IEMA to establish a NIMSCAST logon and password to complete the required task and roll it up to the state if Illinois. They must have faxed a copy of their resolutions to Deb Watts.
- They know what class each person needs to take and where to find that class.

The biggest problems staff has encountered to date are:

- Agencies believing they are NIMS compliant because they sent in resolutions or took the online classes
- Agencies achieving NIMS compliance in 2005/2006 but not “rolling up” to the State their 2007 required NIMS activities
- Not understanding that there are annual requirements that change
- Completing all activities but not getting the NIMSCAST password from the State

However, the biggest issue is the disagreement or misunderstanding somewhere along the line about the Department vs. Jurisdiction NIMS compliance issue. Can a police department be in compliance if their city or village is not?

Tactical Emergency Medical Support (TEMS) – Griffeth

ILEAS continues to receive a lot of calls and inquiries as to how ILEAS can assist their agency with medical training. Agencies would like to see TEMS training and support for their special teams. There is also a desire to acquire basic self-aid and buddy aid for all their officers. In light of the most recent shootings nationwide agencies want to ensure that their officers are properly trained and equipped to handle these injuries either to themselves or a fellow officer until advance medical care can be rendered.

Mark has been working with the Illinois Dept of Public Health TEMS sub-committee to determine how ILEAS can help. ILEAS sponsored a TEMS summit on March 30, 2009. Several physicians, paramedics and tactical commanders from around the state attended. Additionally, John Gnagey, director of the National Tactical Officers Association (NTOA) and Dr. John Croushorn from the University of Georgia Tactical Emergency Medicine also attended. ILEAS has conducted discussions with the NTOA to possibly bring some Tactical EMS training to ILEAS Training Center and later rolled out to remote locations throughout Illinois.

Private Sector Committee – Haas, Casella

The ITTF Private Sector Committee-sponsored Private Sector Alliance Project (PSAP) continues after 21/2 years to engage public/private representation to promote a culture of information sharing, preparedness and partnership. The Project is primarily focused on prevention and then action-oriented response/recovery activities. The Project initially comprised of two mutually sustaining programs: (1) Infrastructure Security Awareness (ISA)

and, (2) Mutual Aid Response/Resource Network (MAR2N) has expanded since January 2009 to include other initiatives. These initiatives continue to build on partnerships of private sector awareness and participation to further solidify a foundation for mutual exchange of information and assistance.

The recent initiatives are as follows:

- The MAR2N database is progressing from planning to execution of a user-friendly system of critical resources to aid in emergency response efforts. This system will be categorized by NIMS resource type and be accessible for the Private Sector Liaison position at the SEOC. The database builds on the ILEAS resource system but will accommodate target specific needs of the PSAP Project.
- SEOC Private Sector Liaison – volunteer private sector individuals are now in place to respond and partner with peer public agency representatives at the activated SEOC to augment State.
- The Private Sector web page is updated to include an official logo, a link to the FBI's private sector initiative InfraGuard and automated, "fill-in" applications for membership to ISA and MAR2N.
- The Private Sector Committee is restructuring to include non-governmental entities as part of the committee as well as supplementary private sector participants.
- A kick-off meeting concept is in the planning stages to convene public agency and business stakeholders in a forum to "officially launch" the Private Sector Alliance Project and discuss opportunities for initiating additional and expanding existing public/private partnerships.
- *A pilot initiative between the private sector's ASIS International, ILEAS and STIC to fund salaries of intelligence analysts is progressing through the interview stages for hiring. The individual, through an ILEAS contract, will address the intelligence information requirements of the private sector in conjunction with other STIC analysts while deployed at the fusion center.*
- Mutual Inter-State Initiatives with Private-Public Partnerships continue with Illinois and California sharing strategies, best practices and lessons learned.
- Outreach during private sector activities was initiated and PSAP conducts presentations/displays at private sector workshops, conferences and trade shows to inform and reinforce homeland security awareness and private-public partnerships in Illinois.


ILEAS Mobile Response Trailer – Regan

ILEAS obtained a 29' camper surplus-FEMA trailer from CMS. It has been set up with StarCom21 and VHF radios and outfitted with generators and other equipment. It is available for deployment to support ILEAS assets.
