Governing Board Meeting January26, 2017

Audit

On October 27, 2016, The Governing Board selected the audit firm of Martin, Hood, Friese and Associates from Champaign as ILEAS' auditor. Staff made that recommendation based on the desire to get a fresh "set of eyes" on ILEAS' financial processes Legg & Legg had been ILEAS' auditor from the beginning (ten years) so having a new perspective with a different firm was desirable.

The audit by Martin, Hood, Friese and Associates (MHFA) has been completed. A copy of that audit has been provided to you electronically. Paper copies are available if you so desire. Please see the letter to the Governing Board from the auditor located in the financial packet. Greg Douglas, CPA, MHFA Senior Manager, will be at the meeting to review the audit and answer any questions you may have.

The audit review resulted in recommendations and proposed changes to the ILEAS fiscal process to make it even stronger than it already is. Changes include:

- One change is the Prior Period Adjustment, which recorded both accrued Paid Time Off at fiscal yearend along with accrued payroll at fiscal year-end. The prior auditor did not record these adjustments as the focus was mostly on the grants.
- A recommendations was also included to ensure the recording of journal entries, such as fixed assets and accounts payable, are in the correct fiscal year. Journal entries were made in the audit to properly record receivables and payables in the correct fiscal year.
- There was discussion during the audit process regarding creating additional internal financial reports to be completed and then formally reviewed by management on a monthly basis. Management agrees with the changes and recommendations and is currently making improvements to the current internal financial reporting and recording.

Requested Board Action

Staff requests the Board accept the audit report as presented. Staff also requests that the Board accept and authorize the recommended changes suggested by the audit.

Line of Credit Update

As reported at the last Board meeting, ILEAS had to utilize \$60,000 of our \$250,000 line of credit to pay a vendor. Since then, ILEAS has paid the loan in full. The final cost in interest was \$86.56. ILEAS still has access to that line of credit but has no need at this time to access it.

Requested Board Action

Staff requests no action by the Board.

ILEAS Staff Pay Raises & Specific Raise for IMERT

A short history of ILEAS staff raises:

- The Governing Board authorizes raises when it approves the annual grant budget.
- ILEAS has routinely provided 3% raises for staff; not only for COLA, but because ILEAS offers no benefits like retirement or health care.
- On July 1, 2015, all ILEAS staff received a 3% raise.
 - o There were four exceptions Jim Page, Jan Plotner, Larry Evans and Jim Luecking.

- A 3% raise was budgeted on July 1, 2016but temporarily held by the Executive Director because of the lack of a State budget and providing raises at a time when a layoff date had been established was not acceptable.
- In October of 2016, ILEAS learned of a 35% budget cut for FY16.
 - In the reallocation of FY15 and FY16 funds to compensate for this cut, the raises for this year were sacrificed.
 - o Staff was provided a preliminary notice on June 23rd and a final notice October 27th.
- During the aforementioned reallocation of the FY 15 and 16 grants, ILEAS management did build in a 3% raise for staff starting July 1, 2017.
 - However, unless the State of Illinois adopts a firm budget by June 30th, ILEAS will be in the same position as the last two years with regard to raises.
- The Governing Board approved the raises which were contained in the revamped budget approved

Chris Jansen

ILEAS is the fiduciary for a grant to employ Chris Jansen. Jansen is the only full time employee for the Illinois Medical Emergency Response Team (IMERT). Likewise, it has been a few years since Jansen received a pay raise. Jansen is technically an ILEAS employee so he has been subject to the freeze. Mary Connolly, the IMERT Director, put a 7% increase for Jansen in the IMERT budget, which was approved by IEMA.

Requested Board Action

Staff requests that the Governing Board approve the \$4,000 raise (from \$56,000 to \$60,000) for IMERT Medical Programs Grant Coordinator Chris Jansen as proposed.

Dues Amnesty

At the Board meeting on August 25, 2016, the Board voted to waive past due dues if the delinquent agency paid their 2016 dues. Six agencies accepted the deal and are now current.

Changes at IEMA and ITTF

Last fall, the long-time ITTF chair and IEMA Grants and Preparedness Manager Don Kauerauf has resigned from IEMA to accept a position of Deputy Director of the Illinois Department of Public Health. Michele Hanneken resigned from ITTF/IEMA and took a position with the Governor's Commission on Volunteerism. Kauerauf was replaced half time by Jenifer Johnson, IEMA's General Counsel. Hanneken was replaced half time by Ashley Fleck who works in the IEMA fiscal division. 18 months ago, there were four full-time employees at IEMA managing homeland security and related grants. Now there is one full-time two half-time employees.

The State's hiring freeze is preventing IEMA from replacing the vacancies. As a result, everything is moving very slowly – purchase orders, grant work, policy discussions, legal paperwork, etc.

While Don Kauerauf's position of IEMA Bureau of Preparedness and Grants Administration was filled part-time, the position of the ITTF Chair was left open. The Governor's Director of Public Safety, Rodger Heaton, convened a group of veteran ITTF members to consider the path forward. This group consisted of the State Police First Deputy Director, IEMA Director, one of the Chairs of the Emergency Management Committee, Director of IFSI, Director of MABAS and Jim Page. The group met once in Peoria and then met on conference call a few times. A complete revision of the structure of ITTF was put forward and accepted by Director Heaton. What follows is the basic description of the newly organized ITTF:

- Rodger Heaton is now the permanent Chair of the Illinois Terrorism Task Force.
- The IATTF previously had 17 committees and numerous workgroups. It now has five committees:
 - Law Enforcement Mutual Aid
 - Fire Mutual Aid

- Emergency Management
- o Transportation/Logistics/Infrastructure
- Public Health
- See the Organization Chart below.
- Each committee will have a chair and a vice-chair.
 - One of the two will be a State representative and one will represent local interests.
 - Director Heaton will choose who will be the chair and vice-chair from nominations made at the first committee meeting.
 - His choices will reflect a mix of chairs from both State and locals so that all the chairs are not State agencies.
- Each committee must meet at least quarterly before the full ITTF meeting
 - Each committee must complete a standard report to the ITTF about its activity
 - NOTE THE LAW ENFORCEMENT MUTUAL AID COMMITTEE MET ON JANUARY 5th.
- Every member of the full ITTF must participate on a committee to keep their membership in ITTF
- The ten chairs and vice-chairs of the five committees will meet monthly as a "Council of Chairs" with Director Heaton as the Chair.
 - The Council of Chairs makes recommendations to Director Heaton who makes the final decisions
 - The terms are for one year at a time.
- Ad hoc workgroups with membership from multiple committees can be formed and disbanded as the need arises.

 Director Heaton is exploring the hiring of an ITTF Coordinator to do the daily communications and coordinative work.

What does this mean for ILEAS?

The ILEAS Governing Board is no longer the de facto Law

Enforcement Mutual Aid Committee. However, the newly constituted Law Enforcement Mutual Aid Committee largely consists of ILEAS member agencies. The ISP First Deputy Director, Chad Peterson and Jim Page have discussed the committee makeup and have worked together to get the group organized.

Chad Peterson will be the State agency chair or vice-chair. The committee nominated to Director Heaton that Director Page be the chair or vice-chair position representing local agencies. (nominated by SOS PD and seconded by ISP – thanks Col. Williams!) We are waiting for Director Heaton to make a decision as to who is the chair and the vice-chair.

Requested Board Action

There is no action necessary by the Governing Board.

Election of Governing Board

The online process for Governing Board nominations opened on January 9th and will close on January 27th. As of this writing, 40 chiefs and sheriffs have been nominated for Board positions. There is at least one chief and one sheriff nominated from each region to date. The online election process will take place from February 13th to February 24th. Shortly afterwards the election results will be announced and the new Board will be seated on March 14th at the Annual Conference.

Requested Board Action

Staff requests no action by the Board.

Physical Inventory

Grant guidelines, Grant Accountability and Transparency Act (GATA) and ILEAS policy require physical inventories of equipment with a value of over \$5,000. That is a large list consisting of over 2,800 items located at over a 1,000 agencies. Given the fact that ILEAS has been the fiduciary for other organizations in the past exacerbates the task, as many recipients are non-law enforcement. However, ILEAS, as the grantee, is responsible for the inventory of that equipment. Staff has conducted an extensive review of the number of items for which we are accountable. Inventory Coordinator Kent Jepsen has been working with Mick McAvoy, Jan Plotner and Larry Evans to devise a plan to conduct a comprehensive inventory process. ILEAS has kept detailed records and ILEAS has extensive institutional knowledge about where the equipment is and how it was purchased.

The path that has been developed is as follows:

- Query the inventory database and develop a list of all qualifying equipment over \$5,000 in value
- Identify equipment for which ILEAS was the fiduciary belonging to another organization.
- Develop MOU's to transfer equipment from ILEAS to:

MABAS
 Logan County/IESMA
 Radiation Detectors
 EOC Technology

o ISP ICLEAR, Credentialing, SABA LMS

Develop MOU's to transfer equipment to ILEAS from:

o MABAS Communications Gear

Logan/IESMA

- Transfer responsibility and ownership from ILEAS to local agencies for MDCs.
- Complete the StarCom21 radio ownership transfer process

Once that is complete, ILEAS staff will be able to focus on the 600 remaining items that are ILEAS' actual law enforcement responsibility. This is largely communications gear, training center equipment, vehicles and special team equipment.

Requested Board Action

Staff requests no action by the Board.

RPC Activity Report

In December of 2015, ILEAS initiated the collection of data regarding the activity of the Regional Planning Coordinators (RPC). As each Board member is aware, the RPCs are an invaluable resource for law enforcement agencies across Illinois. However, ILEAS was unable to quantify their activity for budget justification and planning. Our contract programming vendor, Indilus (Tyrus deJarnette and Stewart Wood), developed an online tool whereby such data can be captured and compiled. The RPCs can access the tool on their mobile devices. They have the ability to enter their activity into the software throughout their day. The table at the end of this document summarizes the data from calendar year 2016.

Requested Board Action

Staff requests no action by the Board.

Communications Program Update

An update of the Communications Program activities:

What has been done to-date:

- the Starcom21 user fees have been billed and paid through June 30, 2017
- the process of identifying agencies retaining individual user licenses is done & they have been notified
- the notifications of the termination of StarCom21 user fees for other agencies has been accomplished
 - The status of those notifications are:
 - 1,303 notifications sent out electronically and physical mailings
 - 893 agencies have responded
 - 367 are keeping their radios and paying for them from this point on (Motorola notified)
 - 526 indicate they are returning their radio
 - 424 have already been returned
 - 302 Final Notices Letters were sent in Mid-January
 - 150 agencies contacted ILEAS in three days due to the final notice letter
 - 260 agencies have not responded whatsoever
- 2,500 Radios remain funded by ITTF that includes Statewide Special Teams, Statewide Caches and approximately two radios per county (EMA and primary dispatch per county).
- Repurposing Surrendered Radios
 - 113 radios will be assigned to MABAS Special Teams across Illinois in progress
 - o 130 portables will be assigned to UCP to add to the statewide cache
 - Build StarCom21 case mobile caches
 - Transfer ownership remaining radios to those agencies that have requested additional Starcom21 radios and will to pay the user fee.
 - The validation exercises for all nine ITECS trailers have been completed and a report prepared.
 Starting in January of 2017, the 16 Mobile command Posts will be validated as well.

- Approximately 130 VHF case radios will be prepared and stored at ILEAS as an important backup cache. Thirty units are ready to go now.
- The ILEAS basement radio room remains the storage and location where radios will be prepared for redistribution.

Requested Board Action

No Board action is anticipated.

Cubs Deployment

On November 4, 2016, ILEAS deployed to Chicago members of various Mobile Field Force teams in Regions 3 and 4 pursuant to a request from Chicago PD for help with the Cubs Parade and Rally. It should be noted that NIPAS also responded to this call for assistance. 126 Mobile Field Force team members from 85 agencies responded. They were assigned positions along the parade route and at the rally itself.

The agencies responded as normal with no assumption of reimbursement. However, after the event, ILEAS staff worked with Chicago PD, the Mayor's Office and the Cubs to determine whether funds might be available for reimbursement. Just prior to Christmas, the Cubs organization agreed to reimburse straight and overtime for the responding officers. Of the 85 responding agencies, 55 of them submitted a request for reimbursement. Staff opened up an online reimbursement process. An invoice for \$51,423.73 was submitted to the Cubs On December 28, 2016. Please note the \$51,423.73 is a combination of \$49,925.97 plus and an ILEAS administrative fee of \$1,497.78 for processing. ILEAS is awaiting that payment. Upon receipt of the funds, ILEAS will issue checks to the submitting agencies.

Requested Board Action

No Board action is anticipated.

Region 4 North Mobile Field Force

At the last Governing Board meeting on October 27, 2016, the Board decided to create a new Mobile Field Force team in Region 4 North. This team will encompass the counties of DuPage, Lake and Cook (north of I-55). ILEAS was able to acquire the equipment truck, trailer and the F350 truck with funds from FY14. The rest of the funds to create this team will be invested in the rest of the team and member equipment.

As per the agreement with NIPAS, ILEAS staff will not recruit NIPAS Mobile Field Force Team member agencies for this new team. However, if a NIPAS agency does want to move to ILEAS, we will not bar them from joining. If such a situation arises, ILEAS will notify NIPAS immediately. As a result, in the next week, ILEAS will send out an email to all eligible agencies announcing the formation of the team. A list of all the eligible agencies has been developed. As per every other ILEAS team, agencies must:

- Be NIMS compliant
- Be current on their dues
- Be an ILEAS member agency having adopted the most recent LEMAA

A significant amount of the funding for this team are UASI funds which must be spent in Cook County. An agency in Cook County must accept the vehicles and the equipment. A Team Leader must be selected and a local governance process established.
