Line of Credit Update

As authorized by the Board, a \$250,000 line of credit with PNC Bank was established. Once the financial emergency was over (State's withholding ILEAS grants due to budget fight), there was no immediate need to access the line of credit for payroll. However, on September 18, 2015, ILEAS access the line of credit and borrowed \$55,000 to pay for the Pontoon Beach Command Post vehicle. On October 19, 2015, ILEAS paid back the bank in full. This tactic was intended to establish a positive historical practice of ILEAS paying back loans. The line of credit is good for one year.

Requested Board Action

No action is requested by the Board.

Portable X-Ray for EOD Teams

The Bomb Squads have identified a need for FPX Nex-Ray NANO portable X-ray machines. These are the size of a MDC type laptop and are used as described below.

- Recent and future special events such as marathons, where the bomb squads have had a response concern has uncovered the need for responding bomb squads to have a "man-portable" X-ray system to safely examine suspicious packages in an expeditious manner. Systems currently deployed by local bomb squads require external power and are large and require a vehicle to transport it. Man-portable X-ray processors will eliminate that concern and allow bomb techs to safely and quickly X-ray suspicious packages with minimal disruptions to events.
- Nationally, Bomb Squads are being asked to integrate with SWAT teams. A man-portable X-ray system
 would allow local bomb techs to properly support the tactical mission. This system would allow bomb
 techs to safely and quickly conduct X-rays while supporting their agencies tactical mission.
- "Man-Portable" X-ray systems are also beneficial for day-to-day operations of local bomb squads.
 Local squads would have another option for conducting X-rays during routine calls for service where large X-ray processors are either too cumbersome, or not right for the task.

This unit is recommended by the Hazardous Device School in Huntsville, Alabama and according to the FBI is the only one of its kind.

They cost \$35,500 each. A total of 9 of them would be \$319,500. This would be funded by a combination of the 2014 and 2015 funds budgeted for Bomb Squads and some surplus funds that were placed in the 2014 budget to fund the new SRT Trucks and MFF chassis replacement. These funds were not used because we used sweep funds from previous year's grants to help funds those vehicle purchases.

These units are not manufactured until they have a firm order and the delivery time is normally 6 months. This would be problematical because the funds earmarked for this purchase expire June 30 and 6 months leaves no room for delay. However a discussion with the company has led to a promise of delivery by June 01, 2016 if they receive the PO by mid-December. Details for the NANO X-ray are attached to the financial packet.

Requested Board Action

Staff requests that the Board authorize the purchase and distribution of the NANO X-ray machines for the local EOD teams in Illinois.

Communications Grants

<u>Grants</u>

For several years, ILEAS was the fiduciary for the ITTF radio communications grants. That stopped in 2013 as the Co-chair of the ITTF Communications Committee, Wauconda Fire Chief Dave Dato, wanted the radio communications grants to run through his agency at Wauconda Fire. As a result, a large amount of radios from different funding sources, including ILEAS funding sources, were located at the Wauconda Fire Protection District. Late last summer, Chief Dato retired. The new Wauconda Fire Chief does not want to continue to house most of the equipment, or to be the fiduciary for the grants responsible for sub-recipient monitoring all over the State of Illinois.

On August 17th, ITTF asked that ILEAS pick up the responsibility to finish the FFY14 grants and to accept the FFY15 grants when they are issued in September. The Board voted to accept the unspent FFY14 grants previously issued to Wauconda; to execute an MOU between IEMA, Wauconda and ILEAS to transfer the equipment to ILEAS; and to partner with IEMA to develop an overall interoperable communications plan for Illinois.

Part of accepting the FFY 14 grant from Wauconda is to participate in a complete inventory of the radios and communications that Wauconda and other agencies currently possess and to come up with a universal plan to redistribute radio caches throughout the State. On December 1st and 2nd, 2015, Inventory Coordinator Kent Jepsen, Communications Liaison Russ Gentry and IEMA staff Ron Clark spent two days inspecting and inventorying the communications equipment stored at Wauconda Fire. They also inspected the records that former Chief Dato had maintained. They returned to ILEAS with a significant amount of radio equipment. Some was left (receipted) at Wauconda as a cache. They also returned with a copy of all the records. ILEAS staff now have a good working knowledge of what was purchased and where it is. This will provide a good basis upon which to make future purchasing decisions.

StarCom21 User Fees

As shown above, there is \$354,906 available to pay for StarCom21 user fees. ILEAS staff has met with Motorola and discussed the extension of the current licenses. To date, Motorola and ILEAS have tentatively agreed upon a fee of \$312,000 to pay for StarCom21 user fees from February 1, 2016 through June 30, 2017.

That reflects the following:

- a decrease of radios from 3,688 to 2,600. 1,000 radios will no longer be paid for by ITTF/ILEAS.
- an increase in duration of the contract to 17 months.
 - o Motorola is providing 5 months of no cost coverage and is requesting 12 months of payment
 - o This arrangement gets the Starcom21 contract on both a State and Fiscal year cycle.
- ILEAS is working with ITTF to develop a letter that will go out to every agency in Illinois (all disciplines) informing them of the change.
 - A plan for deciding what agencies keep their radios and which ones should return theirs will be developed

This StarCom21 contract needs to be executed prior to January 31, 2016.

Communications Plan

ILEAS has been tasked with the development of a plan to develop Regional Technology Support Teams AND to review and possibly realign the current radio caches. ILEAS staff has started the development of this plan which will be presented to the Board in the next regularly scheduled meeting.

Requested Board Action

- Staff requests that the Board accept the FFY14 grants as received from IEMA and direct staff to develop an interoperable communications plan in concert with IEMA for consideration at a later date.
- Staff requests that the Board authorize the expenditure of budgeted funds to contract for StarCom21 user fees at an amount not to exceed the budgeted amount of \$354,906.

Secretary Vacancy

Wayne Gulliford is retiring within a week of the Governing Board meeting. This creates a vacancy at the Secretary position of the Executive Officers. The Board will have to consider his replacement. Here are the bylaw requirements of the election of Officers:

- **3.17 Executive Officers**: The Public Agency ILEAS shall have a President, Vice President, Secretary, Treasurer and Sergeant at Arms who shall be appointed by and from the Governing Board of ILEAS, at its discretion. The officers shall have the duties, responsibilities and powers accorded to them by the Bylaws of ILEAS as the Bylaws are established and may be amended from time to time by the Governing Board. The Executive Officers shall be elected from members of the Governing Board who shall have been Governing Board members for at least one year.
- **3.18 Executive Officer Term**: The Executive Officers shall hold office for a term of two years or until their successors have been duly elected, providing they continue to qualify for active membership during their term of office. All officers may be reelected or appointed for additional terms of office. The President, subject to advice and consent of the Governing Board, will fill vacancies to complete the terms of Executive Officers until the next election.
- **3.19 Nominating Committee:** The President shall appoint a Nominating Committee consisting of three members of the Governing Board. It shall be the duty of the Nominating Committee to provide a slate of qualified candidates to be Executive Officers. The current officers shall not serve as Nominating Committee members.
- **3.20 Election Procedures:** Election shall be by ballot. If there is but one nominee for each office, the President shall cast one vote for each nominee to office. A majority of the members present shall elect on the first ballot. In the event no candidate receives a majority vote, a second ballot shall be taken between the two candidates receiving the highest number of votes. Should the vote result in a tie between candidates, the candidates with the same highest number of votes shall participate in a "coin toss" selection process to determine who shall fill that Executive Officer position. Elected officers shall assume their duties of office upon election.

Requested Board Action

Staff requests the Board discuss and proceed on the nomination and election process for a replacement of Wayne Gulliford as ILEAS Governing Board Secretary.

Mobile Field Force Standard Operating Guidelines

At the August 2013 Board Meeting the Mobile Field Force SOG's were presented for approval. These SOG's were drafted by Jim Luecking in 2005 and adopted by the team commanders in 2006. The ILEAS Board never officially adopted them but we have been operating with them for the last 9 years. Jim Luecking with the help of a committee of team commanders updated the SOG's in 2013 and they have reviewed them again over the past 4 months. The team commanders recommended them for approval at their September meeting. Most of the changes were to language and to address how we actually do things, rather than how we thought we would do things before the teams were even fully formed. Due to the ongoing discussions with the NIPAS MFF they were not approved at that meeting.

Governance:

The major change is the addition of the Governance section. This was in response to Board direction after the Region 4 South team presented their SOG's which formally included the South Suburban Chiefs Association in their governance. This section as drafted provides for an ILEAS Regional MFF Committee made up of the ILEAS Regional Co-Chairs and 3 Chiefs or Sheriffs who agencies participate in the Regional MFF. Their duties are:

- Recommend a team commander for the ILEAS Regional Mobile Field Force to the ILEAS Board President for approval.
- Approve the team commander's assistant and executive officer.
- Recommend approval of dues to be paid by agencies who participate in the Regional Mobile Field Force.
- May authorize emergency and non-emergency activations of the ILEAS Regional Mobile Field Force.

There was also a concerted effort to spell out the *non-operational* role of ILEAS and the ILEAS staff.

The regional team commander will be responsible for notifying a Regional Co-Chair of a request for activation. If neither Co-Chair is available any member of the Mobile Field Force committee may be contacted. If there is any concern about the criteria for the activation, the person notified will consult with the Mobile Field Force Committee for approval for the activation.

- The Mobile Field Force Committee can disapprove a request for activation.
- An activation request for an ILEAS Regional Mobile Field Force response cannot be denied on the basis that a requesting ILEAS member does not participate in the team.
- The ILEAS Regional Mobile Field Force cannot respond to non-ILEAS members. A Sheriff may request a response to a non-member municipality in his/her jurisdiction.
- The regional team commander or his/her designee will be responsible for notifying the team members of an activation.
- Team members need to obtain approval to respond from their organization per their individual policy.
- The chief or his/her designee of any ILEAS Regional Mobile Field Force participating agency has the right to not participate in a callout due to manpower or other reasons.

First Amendment Protection:

In October 2013 a First Amendment Protection policy was added to the SOG's to stress the importance of the First Amendment in civil disobedience situations. This is based on US Department of Justice guidance.

Requested Board Action

Staff requests that the Board approve the Mobile Field Force Standard Operating guidelines as proposed.

Future Legislation

ILEAS is getting a head start on potential legislation in the next General Assembly which starts in January. We are working with John Millner to develop four pieces of legislation as follows:

Making the Homeland Security Emergency Preparedness Trust Fund a "Continuing Appropriation" ILEAS is proposing a modification to the enabling statute which created the Homeland Security Emergency Preparedness Trust Fund. The language added to this section mirrors the same language added to Section 24 of the Toll Highway Act because of the same reason which was based on a court decision. This language allows the State to continually provide funding for the Tollway independent of the State General Budget. ILEAS is proposing adding the same language to the Statute creating the Homeland Security Emergency Preparedness Trust Fund which consists entirely of non-State funds.

Law Enforcement Mutual Aid Omnibus Bill

Mick McAvoy has identified several statutes located in various chapters throughout the Illinois Compiled Statutes that address police mutual aid. When read together, they create a confusing environment and unclear guidance on how mutual aid should. Our initial thought is that all of those statutes be repealed and replaced with a statute that draws together all the issues and is located in one place in the Statutes to provide municipalities and counties with clear modern guidance regarding mutual aid. Mick McAvoy and other staff are currently reviewing those statutes and will start building statutory language later this fall.

Funding

This needs to be tried again. There are costs associated with response that need to be paid separate from Federal funds. The most pressing issue is the Operational vs. Planning and the Terrorism vs. Natural Disaster problems. Three years ago ILEAS tried \$1 added to vehicle insurance policies. Because of the ILETSB issue

at the time as well as resistance from the insurance industry, that failed to gain any traction. Last year we tried \$3 on license plates together with MABAS. Because of the State budget mess and opposition by the Governor's Office, that failed as well. If we want to stick with this license plate strategy, there are two routes to go – stay with MABAS and try the \$3 again; OR, go it alone and ask for \$.25 to \$.75 per plate just for ILEAS.

If we go for the last option, ILEAS could receive between \$2 and \$6 million annually. That amount, added to what we receive in Federal funding would be sufficient to solve the previously described problems as well as addressing the lack of capital replacement funds. It could also help compensate for the anticipated loss of part of our buildings at the Training Center. Additionally, on 2010, ILEAS did get a bill passed that created the *Illinois Law Enforcement Alarm System Fund* (Public Act 097-0453). The actual law is attached this document. 66.7% of the money in that fund must be spent on law enforcement and terrorism operations. 33.3% must be spent on airborne operations. Therefore, theoretically, a \$.50 per license plate fee would produce \$4.5 million so \$1.5 million would go to air operations. The Board would decide how that money would be spent. For example, it could be as simple as the Board authorizing ISP, CPD and Air One each \$500,000 to pay for fuel. The other \$3 million would be spent to enhance current ILEAS programs.

Drones

A direct reading of the current drone law, restricts law enforcement from using drones except under very specific circumstances. None of those circumstances include a training exception. Neither are there any 3exceptions for use of a drone – or a tethered balloon – to be used as a communications relay. New technology allows a repeater to be placed on a drone to provide regional communications during a disaster or other incident. The current drone law prohibits law enforcement from using or having anyone else use – a drone for those purposes. Staff believes that the current drone law needs amended to account for these relatively benign uses of a drone which do not threaten civil liberties in any way.

John Milner and Jim Page will discuss all of these bills with the Chief's Association and the Sheriff's Association prior to any submission.

Requested Board Action

Staff requests that the Board authorize moving forward with these proposed bills under the supervision of the Executive Officers. They must be submitted to the General Assembly prior to the next Board meeting.

New LEMAA Status

The adoption of the new Law Enforcement Mutual Aid Agreement (LEMAA) continues its implementation. This is an overview summary:

1,044 Total Agencies

861 New LEMAA

927 Original Mutual Aid Agreement

As of December 2, 2015 ILEAS has received either resolutions or signed LEMAAs from:

697 Municipalities

100 Counties

- 30 Public Universities/Colleges
- 4 State Agencies
- 10 Private Police
- 20 Special District Police
- Total (93% conversion completion)

ILEAS is currently averaging around 1 new LEMAAs arriving every other week. As the Board is aware, the original mutual aid agreement is still in effect for each agency that signed it until the agency signed the new

one. In the new LEMAA process, ILEAS did pick up three agencies that were NOT members under the old agreement. The Regional Planning Coordinators are working with their agencies to get the LEMAAs signed. A priority list of 379 agencies was established for them to include sheriffs, special teams' agencies and agencies with over 50 sworn employees.

- 1. County Sheriffs......2 Remaining
 - a. McDonough & Mason
- 2. Agencies with over 50 sworn (not on special teams or sheriffs)... 6 Remaining
 - a. Maywood, Harvey, North Chicago, METRA, Univ. of Chicago
- - a. IL. Dept. of Natural Resources

That list is currently down from 379 to 9 agencies – 99% of our priority agencies are completed.

Restrictions on agencies that do not have new LEMAA.

All agencies that have officers/deputies on special teams have signed the new LEMAA.

Non-Member Affiliate Agreements

The Executive Director is required to report to the Board any Non-Member Affiliate Agreements that have been signed since the last meeting. This month that list is **AMTRAK.**

Requested Board Action

No action by the board is being requested.

ILEAS Conference

At the end of the Conference in 0215, ILEAS secured the dates for the 2016 conference on the same weekend in April – the 24 thru 26, 2016. Within the last few months, the Illinois Association of Chiefs of Police moved their Annual Training Conference in Schaumberg to April 21-22, 2016. It is believed that the Chief's Conference being moved to virtually the same weekend as the ILEAS Conference would significantly negatively affect the ILEAS Conference. ILEAS examined other options up to and including, 1) canceling the conference for one year, 2) merging with IEMA's Conference in September, or 3) hold the conference at the same time on a smaller scale. ILEAS and IEMA staff worked for about a month to explore the possible merger of conferences. However, it was determined that for this upcoming year, it was impractical. However, IEMA wants to attempt it in 2017.

At the same time, FirstNet talked about holding a statewide or multiple regional conferences regarding wireless broadband. The FirstNet grant has funds available to pay for such a conference. Given that ILEAS now has the lion's share of communications grants and the responsibility to realign the deployable response system, focusing on communications at the Conference seemed logical.

Given all that and after careful and lengthy consideration, staff would like to recommend the following:

- ILEAS hold its Annual Conference on June 12-14, 2016 at the Crowne Plaza in Springfield.
- Focus this conference on communications and technology
 - Highlight the development of the New Technology Support Teams
- Keep the same basic format as in the past with the following changes:
 - o Focus on communications much like the CMS technology conferences in the past
 - Breakout presentations about FirstNet, LEADS, Century Network, ILTERT, etc.
 - Still do an ILEAS update and regional breakfasts

- Focus on middle management this year to try and get lieutenants, captains, deputy chiefs, chief deputies, etc. to attend.
- For the one full day, invite other disciplines to attend for the communications breakouts
- Primary general session focusing on the new Technology Support Teams and why they are important
- Lower the cost to attend but have the attendees book their own rooms at the State rate

Requested Board Action

Staff requests the Board authorize holding the ILEAS Annual Conference June 12-14, 2016 with a focus on communications and technology.

Republican National Convention

On December 1, 2015, representatives from ILEAS traveled to Cleveland, Ohio to meet with City and Police officials regarding their request for ILEAS to provide assistance with the Republican National Convention that will occur July 18-21, 2016. The ILEAS representatives were:

Mick McAvoy Larry Evans Jim Page Bill Springer

John Konopek – Plainfield Chief of Police, Region 3 Central Mobile Field Force Commander and appointed Task Force Illinois Commander

Eric Allen – Commander from Shorewood PD, Assistant Commander Region 3 Central Mobile Field Force, Assistant Task Force Illinois Commander

Also, traveling separately, Steve Georgas from the Chicago Police Department accompanied ILEAS representatives for the same meeting.

The Cleveland folks were led by Cleveland Chief of Police Calvin Williams. Their group also included a Deputy Chief, Captain, Planning Sergeant, SWAT commander, Special Teams commander, Support Services and Communications commander as well as two representatives from City Legal, the City of Cleveland's Finance Manager.

It was a very good meeting. Chief Konopek, Deputy Chief Georgas, Commander Eric Allen and Bill Springer were able to visit the venue and potential lodging sites. McAvoy, Page and Evans spent a lot of time with the attorneys from Cleveland working thru the significant legal and insurance issues. Bill Springer was able to make connections with Cleveland's radio and data manger as well. Cleveland PD officials want to come to Illinois this spring and observe and possibly train with their Mobile Field Force team members and compare tactical practices.

The only real potential roadblock for this deployment is one of legality. Ohio has a statute that limits the ability of Cleveland to request assistance only to states that share a border with Ohio. It prevents them from requesting assistance from Illinois and other agencies that are coming from Florida, Washington State, Denver, etc. Ohio's solution is to have their Governor declare an emergency so they can use the EMAC system. This also poses an entire set of other significant legal issues. Page and McAvoy are working that problem with Cleveland officials. Other discussions are also underway regarding team tactics and communications. More to follow as developments occur.

Requested Board Action

No action is being requested at this time.

Cyber-Security

Out of a valid concern regarding cyber-security, ILEAS has engaged the US Department of Homeland Security National Cybersecurity Assessment and Technical Services (NCATS) located at the National Cybersecurity and Communications Integration Center. DHS is examining the ILEAS network infrastructure. They are running a weekly scan on our external network address scheme to determine any vulnerability that we might have with our outside facing devices. The scan provides us with details on the specific device, the vulnerability it finds, and the severity of that vulnerability. After their initial scan, it was determined that the ILEAS web server had some high priority issues that needed to be resolved concerning the versions of the web server software that was running the web page. There were newer versions or patches of the running software that provided security fixes for the problems found. We were able to download the needed patches and apply them according. There were also some more minor issues with certificates configurations on our virtual private network and email server that are currently being addressed. With the weekly scans, we are able to get a report that determines if the problems were sufficiently fixed and also if new patches or problems arise.

This is only the first step of a progressively more detailed examination of our system with regard to cyber-security. The process steps are:

- Vulnerability Scanning and Testing (currently underway as described)
- Penetration Testing
- Social Engineering (Phishing)
- Web Application Scanning and Testing
- Operating System Scanning
- Database Scanning
- Wireless Discovery/Identification (ILEAS does not broadcast our internal network so this would not be needed)

Requested Board Action

No action is being requested at this time.

IT Upgrades

Along with the aforementioned cyber-security work, ILEAS is upgrading its information technology infrastructure.

<u>Wi-Fi</u>

One of the most recent projects for the IT environment has involved the Wi-Fi infrastructure. Our training facility provides wireless internet access for training classes, but the previous wireless access points were underpowered therefore the classes were not able to utilize the full potential of our internet service. We replaced the wireless access points with newer technology to allow for faster Wi-Fi streaming rates. The new access points are now able to utilize the newer Wi-Fi streaming standards. The new infrastructure is also now centrally managed so that each access point does not have to be configured individually. The currently solution can be expanded by simply plugging in a new access point and it is configured automatically. After the replacement of the old access points with the newer access points the Wi-Fi speeds quadrupled allowing us to utilize the full bandwidth of our internet provider. It should be noted that ILEAS utilizes Comcast Business as the internet service provider. ILEAS utilizes a separate locally managed high speed fiber network and the State Illinois Century Network for the ILEAS hard-wired network access. This way the public wireless and ILEAS' business internet traffic do not mix at any point.

Data Backups

Another project that has helped the IT environment was the purchase of a new backup solution. The old solution involved merely cloning a copy of the hard drive in case of a disaster. ILEAS was able to easily

retrieve files from backups, but the restoration of a whole server was much more involved. With the current virtual server infrastructure, a backup solution has been selected to take advantage of that. The new solution will allow us to restore our whole virtual environment in a much faster time frame. Also, the new software has other helpful and needed features that the previous software did not have. For example, it is now possible to restore whole email boxes or even individual emails now in a matter of minutes.

Microsoft Office Updates & Capital Replacement

ILEAS is also beginning the process of upgrading to Microsoft Office 16 from Office 10. As part of the IT equipment review, a capital replacement schedule is being developed with regard to servers, PC's, laptops, scanners and printers.

Requested Board Action

No action is being requested at this time.

SEOC Reports

The State Emergency Operations Center (SEOC) has monthly training and planning sessions for all its Liaisons. The ILEAS SEOC Liaisons are Russ Gentry, Dave Fellows and Jerry Whitmore (Randy Wilson as an alternate) who attend those training sessions. This will be a regular part of the monthly Issues Document from this point on so that Board members have a better perspective on the types of activities that the Regional Planning Coordinators and the special teams routinely undertake.
