NARCAN Grant Update

During the COVID 19 situation and the various civil disorder events over the last nine months, some Board meetings were cancelled and others done virtually. During this period, ILEAS moved ahead with NARCAN grant activity. Upon review of records, it was discovered that some grant activity took place that was inadvertently never on an agenda for a meeting that actually occurred. Here are the following issues and authorizations that the staff is seeking retroactively to clean up the missed authorizations.

Purchase of NARCAN

ILEAS purchased 2,028 NARCAN dose units/\$75 per = \$152,100 on September 21, 2020. The Board did approve the overall grant budget which did include the NARCAN acquisition, however, no specific approval was obtained. Since it exceeded \$100,000 it requires Board approval.

Narcan Grant Acceptance

Because of IDPH timing and very delayed grant implementations, the Board has authorized Director Page to accept the NARCAN grant as it came in. Due to the same reasons as outlined above, authorization from the Board to accept the grant when it came in was on an agenda for a cancelled meeting and was not put on a subsequent agenda. As reported last month, ILEAS was awarded what we believe is the final year of the current statewide NARCAN distribution grant. The grant period for this final year is October 1, 2020 thru September 30, 2021 for a total of \$337,874.

New Purchase

Once the Board approves the above-described grant, ILEAS staff will then begin the process of purchasing the allocated amount of NARCAN doses per the new budget. Currently set at \$166,500 although this may change as the grant ages and unspent funds in other line items are shifted to product prior to expiration. ILEAS staff intends to issue an RFP announcement to identify a vendor and determine optimal pricing for this round of product purchasing. Upon completion, staff will present this information to the board for authorization prior to action.

Requested Board Action

Staff requests that the Board approve:

- 1. The expenditure of the \$152,100 of NARCAN purchased in September of 2020
- 2. Acceptance of the new grant that runs from October 2020 thru September 30, 2021 and direct staff to execute the appropriate terms of the grant language.

COVID19 Update

Impact on ILEAS

All the Board members are aware of the second wave increase in COVID19 cases in the state and the country. At the last report in December, ILEAS had five staff members come down with COVID. We increased the work from home strategy and other mitigation was implemented. Over 90 training center events were cancelled.

First Wave COVID19 Vaccination Delivery Planning

As reported in the last Board report, ILEAS was very involved in the distribution of the first wave of vaccine distribution which went off without a hitch. A second distribution was conducted in early January which was also successful. We do not anticipate any further involvement in vaccine distributions.

Vaccines for ILEAS Staff

Northern ILEAS staff were vaccinated by DuPage County Public Health. Central, Southern and Urbana staff have the opportunity for vaccination on January 25th. This opportunity is being provided by the State Police at their headquarters in Springfield. 12 staff members are planning on take advantage of the vaccine at that time.

Requested Board Action

No Board action is requested at this time.

Inauguration Related Activities

Recently, a number of disturbing events transpire in Washington D.C. which led to possible threats of violence in all 50 states. Illinois took measures it deemed necessary to ensure a safe a peaceful period between then and the January 20th inauguration. ILEAS participated in these efforts:

- LE JOC Activation we are part of this group alongside all senior local, county and state representatives to address planning and operational needs including the activation of ILNG units.
- Staffing the Central LESC RPC's Randy Wilson and Tom Gallahue were tasked to work with Major Cushman of ISP along with a number of other agencies representatives to receive and respond to the needs of local agencies as the events progress. This group became operational and worked on site in Springfield through this period.
- Special Teams The Springfield Police Department hosts both the SRT and MFF for Region 6. Special Teams
 manager Skip Frost worked closely with MFF Cmdr Lt. Joe Phillips to ensure they have any assistance that ILEAS
 can provide as they responded to the issues. Skip has worked with surrounding MFF teams to provide
 requested supplemental support.
- After a full ramp up of resources, it appears that the large-scale response succeeded in deterring any type of
 civil unrest. By 1500 on January 17th, a drawn down of personnel began which resulted in the Region 6 MFF
 force via SPD being temporarily relieved. Additionally, our two-person response to the Central LESC will be
 reduced to a single operator for the 19th and 20th.
- SYNC calls will continue with Statewide and NG leaders to continue to discuss any needs that arise while there are "Boots on the Ground" in the Capitol. Prior to the inauguration on Wednesday, the command structure will again return to full strength with a set schedule for SITREPS and Governor's briefings. D

The entire operation was terminated after the Inauguration. No issues of any significance were reported.

Requested Board Action

No Board Action is requested at this time.

Board Elections

Instructions about the 2021 Board Election Nomination Process went out three weeks ago and the week prior to the

Board meeting.

Here is the nomination informational email:

Each Board term is two years. One sheriff and one chief of police are elected from each of the eight regions. The regions and the current board can be found at https://www.ileas.org/governing-board Each elected Board member is allowed to appoint a delegate to attend the meetings in their absence. In order to be eligible to vote for or run for one of the 16 seats, you must represent an agency that has signed the current Law Enforcement Mutual Aid Agreement. Chiefs of agencies that have not updated their mutual aid agreement to the current version are not eligible. There are no term limits. If nominated and re-elected, current Board members can remain on the Board. Meetings are generally every other month at the ILEAS Training Center. For more details regarding the Governing Board, see Article 3 in the current by-laws by clicking Microsoft Word - ILEAS Bylaws Whole Document Jan 12, 2015. Statewide law enforcement agencies such as ISP, SOS, Commerce and IDOC that have MOUs with ILEAS are not eligible to vote. (ISP is already on the Board) While Non-Member Affiliate agencies are part of the mutual aid system and can participate in ILEAS programs, they are not eligible to nominate, vote or run for office. The nomination and voting process occur on the ILEAS website behind your password. Only one vote per agency. The new Board is seated in March. At that meeting Board officers will be elected. You can nominate yourself. The data about who is eligible comes from each agency's ILEAS home page behind your password. Please update it appropriately. If you have any issues, please contact your RPC. Specific instructions on how to nominate will be sent out just prior to the process opening up. Dates: Nominations will be open on January 18th and will stay open until February 5th at close of business. The actual vote for the nominees will open on February 15th and close on February 26th.

Please consider participating on the Board. ILEAS is only as good and effective as long as its member agencies are actively involved.

Requested Board Action

No Board action is required at this time.
