Governing Board Meeting

March 25, 2021

Federal FY21 SHSG and UASI Grants

ILEAS and other ITTF member agencies are involved in the budget process for Federal FY21. Once approved, the Federal 21 budget will run from July 1, 2022 to June 30, 2023. It should be noted that this year Illinois took a \$679,000 cut in the Downstate budget that is now \$14.4 million. The Urban Area Security Initiative grant (UASI) stayed the same at \$69 million. Director Page is this year's chair of the ITTF Law Enforcement Mutual Aid Committee (LEMAC) that reviews and submits grant projects and budgets for law enforcement. The timeline for the grant process is as follows:

- March 25-April 1 – Committees finalize projects based on previous discussions and votes
- April 1 – Committees all meet and review final versions of projects and budgets to submit to ITTF AND agencies submit Grant applications to IEMA
- April 28 - Full ITTF meeting to vote on final budget
- May 5 – Grantees submit final adjusted Attachment A's to IEMA
- May 14 – IEMA Submits grant application for Illinois to FEMA
- September 30 – FEMA issues State grant awards
- July 1, 2022 – Federal FY21 grant period begins

The process was different this year and more committee based. ILEAS worked closely with ISP, ILSOS PD and ILETSB as well as the Chiefs' and Sheriffs' Associations on the committee to submit project proposals. ILEAS' piece of that proposal is as follows:

More details about each grant are available in the handout entitled, **Federal FY21 ILEAS Budget Proposal**. This is a preliminary budget proposal that has yet to undergo a review by the ITTF Council of Chairs, the Full ITTF and IEMA. There will undoubtedly be a noticeable reduction due to the nearly \$700K total State cut.

Requested Board Action

Staff requests that the Board authorize staff to pursue the budget proposed above and to work with State officials to determine a final budget for the Board to review and approve.

Legislative Update Effect on ILEAS

For the new Board members, John Millner is the ILEAS Legislative Liaison. He is the former Chief of the Elmhurst Police Department. He also served in the General Assembly retiring as a Senator. John will provide a quick legislative update for the Board. One bill in particular, HB2788, will negatively affect ILEAS. A quick analysis of that bill is included with the Board packet.

Requested Board Action

Director Page requests Board authorize Page and Millner to work ensure that HB2788 is amended (if passed) to minimize its effect on ILEAS.

ISP And WIU MOUs

The Federal Homeland Security grants from FEMA have a condition that funds must be split 80% for local agencies and 20% for the State itself. This condition has been in effect since the FEMA grants began in FY2002. There is no way that ISP can operate STIC/SWMD Team and IEMA have its staff on just the 20% portion. IEMA has for years traditionally asked ILEAS and MABAS (as representatives of local police and fire agencies) to enter into MOUs that allow the State to spend some of the local money. Since the SWMD Team responds to requests from locals for assistance and that the STIC serves primarily local agencies, ILEAS has traditionally agreed to do this. No money actually changes hands. The real agreement is between ISP and IEMA; ILEAS signs onto an MOU that endorses that arrangement.

This year, there are three MOUs with three State agencies:

Special Teams' Equipment Purchases

There is a Governing Board financial policy that all purchases over \$100,000 from a single vendor must be approved by the Board. There are three purchases for special teams.

LION Suits

LION protective suits come in two varieties. The MT94 suit, the “hot zone” operational garment in WMD and chem-bio incidents, which is approximately \$2,133 per unit, and the LION ERS suit, the “warm zone” operational garment in the same type of incidents, which is approximately \$595 per unit.

- Per the current State FY 21 Preparedness and Response Grant, 45 of the MT 94 suits were authorized by ITTF for a total of **\$95,985**.
- For the ILEAS Governing Board’s consideration, the intent would be to purchase using Federal State Homeland Security Grant (SHSG) an additional 31 MT 94 suits at a total of **\$66,650**, as well as an additional 167 of the LION ERS suits, at a total of **\$99,365**. Combined, those two expenditures to LION would be \$166,015 from the existing ILEAS SRT (grant).

- An additional 13 ERS suits are also proposed for the NIPAS WMD SRT Team, which would come from the UASI grant, for a total of **\$7,735**.

The total expenditure with LION Apparel will be \$269,735.

Night Vision

For the proposed purchase of PVS 14's (and accompanying Rhino helmet mounts), as well as the CNVD long range thermal optics, competitive bids were sought from multiple vendors, with Ray O'Herron winning the competitive bid purchase(s). The intent is to purchase 24 White phosphorous night vision (NVG) units with the mounts, for a total price of \$107,376. The CNVD units (8 units total), were quoted to be \$66,960. Total purchase from O'Herrons for these two items would be approximately \$174,336.

SCBA Bottles

The last item for purchase is the carbon fiber SCBA bottles currently purchased from Safeware. ILEAS is in the midst of capital replacement of all WMD Special Response Team SCBA bottles as they near the end of their prescribed operational life. The State FY21 Preparedness and Response Grant expenditures have already been utilized, with 120 bottles that have already been purchased for \$145,756. The funds are now available to complete this capital replacement project of these bottles by purchasing an additional 115 bottles from Safeware for a total purchase price of \$139,683.60.

Requested Board Action

Staff requests that the Board approve the following purchases:

1. LION suits as described above at a cost not to exceed \$270,000.
2. Night Vision Devices and Related Mounts at a cost not to exceed \$180,000
3. SCBA Bottles as described above at a cost not to exceed \$140,000

Communications Equipment Purchase

Continuing the approval of the Board to purchase equipment over \$100,000, the Communications staff have a request as described below.

Replacement of Starcom21 radios in ITECS and UCP vehicles in the Strategic Technology Reserve (STR)

The current Motorola XTL5000 Starcom21 radios in the ITECS and UCPs, purchased in 2005, are approaching the end of their useful lives. During recent events, especially civil unrest, the need for secure communications has become critical. The current radios cannot use the current StarCom21 and Federal standards for radio encryption, known as AES256. The communications staff is proposing to purchase Motorola APX4500 replacement mobile radios that can provide standards-based encrypted interoperable communications with other encrypted radios in use in the State. There are 22 STR vehicles, so we would propose replacing three StarCom21 radios in each vehicle, plus one radio to be installed at the ITC to provide secure communications at ILEAS when needed. This totals 67 radios. The APX4500 radios are a direct replacement for the XTL5000 radios, using the same mounts, power cabling, and antenna cabling, greatly minimizing installation costs. The old radios would be put into our radio-repurposing program and sent to eligible agencies. Purchase would be from Motorola from the current State of Illinois Master Contract. The cost per radio is approximately \$3,400. 67 units would be purchased for a total cost of approximately \$250,000. Final pricing has yet to be determined as we are waiting on Motorola.

Requested Board Action

Staff requests that the Board approve a purchase of 67 Motorola APX4500s at a cost not to exceed \$250,000.

Capital Replacement Status

The issue of capital replacement has been discussed with the Board often over the last two years. As a refresher, and for the new Board members, Director Page wanted to provide a status update on ILEAS' progress so far.

When ILEAS was formed, annual budgets neared \$16 million for ILEAS alone. Today, there is \$14 million available for **the entire ITTF**. From 2004 to 2010, ILEAS purchased over \$60 million in equipment – much of which needs replaced. In Federal FY10, Congress cut the funding for Homeland Security by 85% nationwide. Several programs were closed by IEMA/ITTF in an effort to do “fewer things well rather than a lot of things poorly.” This is a list of programs/equipment ILEAS no longer supports:

As Board members can imagine, ILEAS spent many millions of dollars on those programs. Some were moved to other agencies (e.g., IMT) but most have been cancelled. Most of that equipment is no longer in our auditable inventory.

Today, ILEAS focuses on Special Teams, Planning, Training, Communications (for all public safety), Mutual Aid and support of one employee for IMERT. In the period of 2003 to 2010, ILEAS purchased millions of dollars of law enforcement equipment for the special teams. Four years ago, ITTF was re-structured and the Communications Committee responsibilities were folded into ILEAS. The ILEAS communications staff support all field deployable emergency communications systems in the State. Oversight and support of the 13 UCPs and the nine ITECS were transferred to ILEAS. As a result, communications equipment management has become a significant role for ILEAS.

Given that ILEAS initially had a lot of funding and bought a significant amount of equipment for Special Teams AND that ILEAS has inherited \$10 million in communications capital assets that were all purchased nearly 16 years ago, capital replacement has become one of the ILEAS' primary focuses.

For a few months in 2017, Director Page was temporarily assigned as the ITTF Chair when Rodger Heaton was moved from IEMA to Governor Rauner's Office. During that tenure, the ITTF developed the Unmet Needs report for the Governor. This document outlined the programs and equipment that ITTF believed were necessary to continue; however, there were not sufficient Federal funds available or the necessary equipment was not allowed by FEMA (e.g., protective gear for Mobile Field Force Teams). This report ended up convincing the Governor's Office to institute the Preparedness and Response Grant funded to a level of \$2.5 million. In the following year, it was increased to \$5 million. This current fiscal year it remained at \$5 million. This is State (not Federal) money.

For the Last three years, ILEAS has prioritized and focused on capital replacement. Much equipment is reaching 15-17 years old. The two primary areas where our efforts are were centered on Special Teams and Communications equipment.

This table lists and describes the major capital replacement projects that ILEAS has undertaken in the last three years.

EOD Teams	Total \$395,685	
Nine Med Eng EOD 10 Bomb Suits and Helmets.	\$359,685	Each of the nine EOD Teams across the state supported by ILEAS were supplied one brand new Med Eng EOD 10 bomb suit and helmet. These replaced suits that were within 1-2 years of being obsolete/expired, and recommended for retirement. An expenditure of nearly \$40k per suit/helmet is often times more money than most of these teams/agencies can expend on their own. The Med Eng EOD 10 is the gold standard in current EOD protective suits.
Mobile Field Force	Total \$713,000	
9 new F350 Pick Up Trucks	\$376,000	The nine new pickup trucks (*Region 4N Mobile Field Force already had one in their initial stand up in 2017) replaced the aging, and in some cases deadlined 2004 Ford Excursions that MFF teams used for their operations. The final three will be received within the next month. These vehicles are vital for use in small squad operations, outfitted for equipment transport and hauling of small equipment trailers, and an incredible upgrade to the operational capabilities of the team. It should be noted that an additional \$25,000 was spent from the regular grant to install heavy-duty handrails and running/step rails to increase their operational effectiveness in delivering patrol strike teams/MFF squads to locations of trouble.
HAVEN protective gear	\$300,000	The new HAVEN protective gear purchased was a consensus choice of all the MFF Team Commanders. It replaced the aging chest, arm and shin protection that had been issued to each MFF team during their initial inception, which in some cases was over 15 years ago. These protective sets are a substantial upgrade, as they are designed to carry the individual officers ballistic panels, have a built in (and provided) hydration system, and just overall much more effective in relation to the Mobile Field Force operations in the current climate of civil unrest. The response to the new protective gear from Mobile Field Force team members and Commanders has been exceptionally positive.
chemical/less lethal capabilities	\$37,500	The chemical/less-lethal project began as a MFF Team Commander request to “regionalize” chemical and less lethal teams to be north, central and south. What 2020 demonstrated was that each of the 10 teams had to be outfitted with their own platforms, munitions, and capabilities. This is an ongoing project, with the first \$37,500 being expended for Pepperball systems, training and live munitions for those systems, and hand deployed smoke and OC canisters. Additionally, the larger MK 9 and MK 46 OC canisters were also supplied from these funds. Due to the size of the purchase, training was conducted here at the ILEAS ITC free of charge within the last month for these systems.
WMD Special Response Team	Total \$2,418,000	
new Lenco Bearcats	\$1.6 million	The new Lenco Bearcats purchase was a project long overdue. The replacement of five (original purchase of 9) Bearcats gives the WMD SRT teams a more reliable, functional, and updated armored vehicle for their SWAT and WMD operations. The Bearcats originally purchased were experiencing significant wear, maintenance costs, and mechanical “down time”, and it was imperative that they be replaced. Two have been delivered, two are arriving within next 3 months, and 1 just ordered with delivery 11 months out. It is the intention of ILEAS to recover several of the Bearcats as the new ones arrive, and utilize a “grant application system” to fill identified gaps in the state where no armor protection is available to law enforcement. It must be noted that these expenses were borne not only by the PAR grant, but also by re-purposed funds from the regular SRT grant that went unused due to COVID concerns and challenges. Since most teams in the system were not allowed to train together for an extended period, a significant portion of grant funding would have been unspent on the teams had those funds not been

		reassigned to assist with capital replacement concerns. It may very well be the lone positive of the COVID crisis, and allowed us to complete projects that frankly would not have been possible with available funding sources.
Capital Replacement Equipment	Amount Spent	Description
LION Chem/Bio protective suits	\$428,000	LION protective suits utilized by the WMD Special Response Teams were nearing the end of their operational lives, and needed to be replaced. These suits consist of the MT 94's (Hot Zone operational suits, costing approximately \$2,150 per unit), and the ERS suits (warm zone suits, costing approximately \$600 per unit). They are the greatest level of protection that can be provided to the WMD SRT teams when operating in a chem/bio environment, and with the recent and future expenditures of both PAR and SRT grant funds, the WMD SRT will have completed the capital replacement of these suits for the near future.
Carbon Fiber SCBA bottles	\$290,000	The same can be said for the carbon fiber SCBA bottles. Nearly all the SCBA bottles in the WMD Special Response Team system were either expired, or set to expire within the next two years (after an operational life of 10 years). Thanks to the PAR grant, it is anticipated that 375 of the new carbon fiber SCBA bottles will replace the current inventory, also completing the capital replacement of these bottles. These bottles are not only issued to the WMD SRT Team members, but also kept as reserves on the air trucks supported by ILEAS to ensure that the teams are prepared for any major incident. This project is also a hybrid of PAR and SRT grant funding.
Atlantic Signal communication headsets	\$100,000	Lastly, the Atlantic Signal headsets/communications systems were a significant upgrade from the aging, and tattered, headsets previously employed by the WMD SRT Teams. This PAR grant supported project fit perfectly with the upgrade of the radio systems (APEX 6000 and 8000) for the WMD SRT. The Atlantic Signal headsets are also incredibly well received by the teams, and significantly improve their communication capability while on missions.

MABAS Replacement StarCom21 Radios	\$94,558	Replacement of 24 MABAS XTS5000 radios with more modern APX6000 radios. Replaces older radios nearing end of life, takes advantage of new capabilities present on the StarCom21 system. XTS radios are not supported by Motorola anymore.
SRT Replacement Starcom Radios for Region 6	\$116,486	Replacement of ILEAS SRT XTS5000 radios with more modern APX6000 and APX8000 radios. Replaces older radios nearing end of life, takes advantage of new capabilities and secure communications present on the Starcom system. XTS radios are not supported by Motorola anymore. Old XTS radios repurposed to Mobile Field Force or used in radio caches.
ILEAS StarCom Cache Radio Replacement	\$96,569	Replacement of 24 ILEAS Cache XTS5000 radios with 24 more modern APX6000 radios. Replaces older radios nearing end of life, takes advantage of new capabilities and secure communications present on the StarCom system. XTS radios are not supported by Motorola anymore. Old XTS radios repurposed for use in other radio caches.
Strategic Technology Reserve (STR) ITECS and UCP VHF & UHF radio replacement	\$106,986	Replacement of 44 old XTL series VHF&UHF mobile radios in the ITECS and UCP vehicles with new APX1500 mobile radios. XTL radios are not supported by Motorola anymore.
Replace Key Variable Loader (KVL) unit for IMERT	\$3,767	A keyloader or KVL loads the encryption key(s) into radios that use encryption. The original keyloaders could not accept or load AES256 keys, so they needed to be replaced. AES256 is the current Federal and Starcom21 standard for encryption.
Replacement 800 MHZ Repeaters in ITECS vehicles	\$75,038	Replacement of six old UHF and 800 MHz repeaters in the ITECS vehicles. Old repeaters were end of life and exhibiting high failure rates. NOTE: These were the final purchases on this project, which started in FY17.
STR Replacement StarCom Radios for NIPAS, Region 8,	\$599,298	Replacement of ILEAS SRT XTS5000 radios with more modern APX6000 and APX8000 radios. Replaces older radios nearing end of life, takes advantage of new

Region 9/11		capabilities and secure communications present on the StarCom system. XTS radios are not supported by Motorola anymore. Old XTS radios repurposed to Mobile Field Force or used in radio caches.

STR Replacement StarCom Radios for Region 6/7, SRT North	\$402,447	Replacement of ILEAS SRT XTS5000 radios with more modern APX6000 and APX8000 radios. Replaces older radios nearing end of life, takes advantage of new capabilities and secure communications present on the StarCom system. XTS radios are not supported by Motorola anymore. ITECS Replacement Project - Electronics	\$194,120	Pilot project to replace one ITECS unit with a smaller, lighter, more agile and capable and much less expensive unit. The original ITECS trucks & trailers cost around \$650,000 ea. in 2006. Since electronics has gotten smaller and less expensive in the past 15 years, we are able to supply an equivalent capability in a van for a cost of about \$250,000 per unit. This includes the Communications equipment to outfit one vehicle.
ITECS Replacement Project - Vehicle	\$55,433	Pilot project to replace one ITECS unit with a smaller, lighter, more agile and capable and much less expensive unit. The original ITECS trucks & trailers cost around \$650,000 ea. in 2006. Since electronics has gotten smaller and less expensive in the past 15 years, we are able to supply an equivalent capability in a van for a cost of about \$250,000 per unit. This line item includes the Ford 1 Ton van chassis and Knaphide body.
Strategic Technology Reserve (STR) ITECS and UCP Telephone Systems Replacement	\$50,704	Current PBX telephone systems on the STR vehicles are old and out of support. These PBX systems will work with the on-board satellite and cellular systems, as well as "donor" phone lines from a nearby building. These systems can easily be reprogrammed to use newer technologies as they come along. Systems on all vehicles are replaced.
NIPAS Mobile Radio Replacement	\$62,516	Replacement of older XTS series mobile radios in NIPAS vehicles with newer APX mobile radios. A combination of VHF, UHF, Starcom21 and multi-band radios. Old radios were returned to ILEAS for reuse.
STR Vehicles, IT Upgrades for ITEWCS and UCP	\$33,713	Replacement network switches and Uninterruptible Power Supplies (UPS) units for STR vehicles. Original IT equipment is old and at end of life. NOTE: This is the first of a multi-year project to replace IT systems in the STR.
