Special Teams Equipment Acquisition Update

The following equipment has been ordered from State FY21 PAR:

- Ninety-four of the LION MT94 protective suits for the WMD SRT Teams for \$200,972
 - Ordered but not delivered
- Carbon fiber replacement bottles (beginning of 3 year project) for \$145,756
 - o Ordered and delivered
- Three Ford F350's which completes the Mobile Field Force teams' vehicle replacement project at a total of \$136,461
 - O Ordered but not delivered
- \$50,000 of HAVEN Gear for the Mobile Field Force teams that will outfit NIPAS MFF team completely, with approximately 20 extras for new ILEAS MFF Members.
 - o Ordered but not delivered
- Less Lethal
 - o pepper ball units, projectiles, training rounds ordered and a train the trainer course purchased
 - o Hand deployed OC, CS and smoke canisters ordered
- \$50,000 of HAVEN protective gear
 - o not yet been ordered.
- NoIR
 - \$70,000 of NoIR laser resistant eyewear for all the special teams has been ordered and received.
 - o Additional 100 units ordered but not yet received.

Financial Reports

Because of the most recent increased COVID19 restrictions, the ILEAS finance staff are working a hybrid work schedule – mostly from home. Additionally, they are in the audit process that is dominating their time. The Board will be sent a finance report as soon as is practicable.

IEMA, National Guard, ISP and ILEAS Project

As everyone is aware, during the recent COVID19 and the civil unrest, the State Police, ILEAS and National Guard created the Joint Operations Command and the Regional Law Enforcement Support Centers. Please see the Issues Document from the July 23, 2020 meeting regarding the JOC and the LESCs. The creation and operation of the JOC and the LESCs worked very well with regard to efficiency of messaging, information distribution, coordinating resource requests across all LE agencies, etc. The relationships built at the JOC/LESC levels were, and are, invaluable. However, there was concern expressed by the State Emergency Operations Center (SEOC) and IEMA about being kept in the dark about ongoing issues.

To that end, the National Guard, IEMA, ILEAS and ISP have been engaged in numerous conference calls since June 23rd about the issue and how to proceed the next time a statewide emergency occurs. The discussion has resulted in a final version of the State Emergency Operations Plan Policy and Playbook Annex for widespread criminal activity outlining the responsibilities, obligations and authorities for the various LE players. There has been two tabletop exercises (in which ILEAS participated) for Gubernatorial Cabinet level agency leaders. A copy of the plan is attached. Please do not redistribute the plan if possible.

Brianna Taylor and Election Activations

ILEAS staff participated in the State Emergency Operations Center and LE Support Centers for both of these events. Special Teams were on standby. ILEAS staff will be doing an after action report for the Board to review in coming weeks. It should be noted that with the exception of being in the SEOC and the Northern/Chicago LESCs, these two events were managed by Zoom, Webex, Microsoft Teams and Go To Meeting. Director Page alone participated in 42 conference/video calls in October and November to date regarding these events.

More to follow when the after action is completed.

Communications Update

During COVID19, the communications staff has been very busy. Here is a summary of issues and activities that they have been managing:

1. Planning

a. IT and video systems upgrades on UCP/ITECs

Working Group established for planning. Several conference call meetings have been held.
 Decision to purchase replacement UPS and switches for all were agreed to be priority. PO was

obtained and replacements were ordered and recently received at ILEAS. Items will now be inventoried and deployed to the teams.

b. Talkgroup, channel additions and programming ITTF radios

i. ILEAS intends to introduce during SC21 negotiations, an update to the Interoperable template for Mutual aid Organizations. This would allow ILEAS, MABAS and others to have additional zones on the template without an increase in cost. Usage would not increase, the radio traffic would only be moved to another talk-group. Rules would remain the same, usage would be for Emergencies, Exercises and Drills.

c. ISP/ILEAS common template

- i. Provided planning assistance to ISP for a common radio template between ILEAS and ISP for future joint operations
- ii. ISP continues to program the Interoperable encrypted zones into their radios allowing for secure communications with ILEAS Teams

d. ITTF School Safety project

i. We continue to participate with the SIEC School Safety Project by developing writing best practices for use by schools

2. Exercise and Training

a. Statewide COMMS exercise (September 23) planning & coordination

i. Statewide Exercise was postponed however, ILEAS/STR continued with Statewide Communications Exercise. Participants included ITECS/UCP's; County EMA's; ISP Communications; Civil Air Patrol; Others. Long-range communications and Airborne Repeaters were tested. HF, local direct, repeater and STARCOM21 systems were tested. Also, Satellite (phone and internet) connections were tested using GoToMeeting as the conference tool. Very successful exercise.

b. Radio training & workshop for STR teams

 Equipment day for STR and other COML students was held at ILEAS. This involved hands-on training and exercise of the MFF and SRT communications equipment. Other equipment available at ILEAS Comms was introduced and trained to familiarization to the teams and COML's

c. Upgrading communications on UCP radios to include ISP talkgroups

- i. After several conference calls with ISP Command/Comms staff, it was decided to go with an APX portable Adapter. The main benefit for this approach is any local agency as well as ISP can bring their APX portable into the UCP and utilize the talk-groups. These units will be permanently mounted in the UCP.
- d. Review and analyze Starcom contract in preparation for upcoming contract negotiations
 - i. We have developed a list of topics to bring up at the SC21 negotiations. We are pushing the state to begin the negotiations soon.

3. Maintenance

a. Radio maintenance

- i. portable and mobile radios, includes firmware upgrades, tuning, battery maintenance, and reprogramming
- ii. All ILEAS team and portable caches of radios have been updated with multi-key encryption. All have been programmed with full interoperable template encryption talk-groups. Battery replacement, analysis and maintenance is ongoing as well.

b. VHF Case radio cache maintenance

i. All ILEAS stored VHF case radios have been tuned, reprogrammed and maintained.

c. Radio inventory

i. All STR and ILEAS emergency cache radios from the summer deployment were recovered and returned to ILEAS and serviced as needed. Since then the emergency cache has again been prestaged for election civil unrest - 50 radios at ILEAS; 50 radios south and 100 radios north.

4. Prototype & Test possible new repeater equipment for teams

a. Investigating replacement repeaters for SRT. Hoping to get a prototype similar to the MFF repeater on in the 800 or 700 MHz bands.

5. Radio re-purposing project - distributing radios, working on acquiring more from agencies.

- a. Negotiating with Tollway to acquire their old XTL/XTS Starcom radios.
 - i. Request letter from ILEAS has been delivered to the Tollway for the available used Mobile and Portable radios (XTL and XTS). No official response has been received as of this date.
- b. Distributed new APX radios to SRT teams.
 - i. All new APX6000 and 8000 radios have been delivered to the SRT teams along with training. The old portables were recovered from the SRT teams. The recovered radios were updated with full encryption and deployed to the MFF teams for interoperability. Each MFF team received 12 encrypted radios. Approximately 75 radios remain stored at ILEAS pending reassignment.
- c. ITECS and UCP equipment distribution and training, includes new telephone systems and antenna kits.
 - i. All ITECS and UCP teams received antenna kits/single charger units. Training was conducted on the remote antenna kits. These kits along with single charger units will be used in cases where single radios are needed vs. a complete cache. An example would be Covid-19 testing stations.

6. Assisted Federal Reserve PD with interoperable communication questions

a. Worked with the Federal Reserve PD to help them understand the STARCOM21 network and answer any questions they may have. They may be applying for SC21 usage

7. Developing ILEAS Online Communications Maintenance and Management system

a. This continues to be an exciting endeavor for the Comms team. Currently the complete update of I2FOG has slowed down progress on the M&M system. However, the I2FOG update is complete and sent to the printers. Work will now continue forward on MMS.

8. Continue development and equipment purchase for New ITECS LITE replacement vehicle.

a. The new ITECS LITE vehicle has arrived at ILEAS. Nearly all the equipment has also arrived and stored at ILEAS. Plans are now being developed to identify the build team and develop an MOU to move forward.

Stop The Bleed Program Close

Because of COVID19 and the effect that it has had on schools, the STB program has essentially been over for the last two months. After discussion with IMERT Manager Mary Connolly and with ITTF Chair Don Kauerauf it was decided to close the program. NO school in Illinois was interested in STB staff training because it is all virtual for the most part. Having the program coordinator, Barb Oliff, sit at home and do nothing would be unethical and improper. It was agreed that the STB program may not be viable until next August of 2021. As a result, Barb Oliff tendered her resignation letter.

As a result, here is the current status:

• Barb's resignation is effective on December 5th (end of a payroll period).

- Mary Connelly will most likely have a position for her at IMERT
- When she resigns, we will have \$42,124 remaining in the Stop the Bleed line item from FY17 HSGP and UASI grants.
- For her remaining time, I have asked Barb to:
 - o Return her equipment (laptop, scanner, etc.) and any kits that she possesses
 - o Collect training equipment that is temporarily in someone else's control
 - o Complete an end of project summary report:
 - What has happened so far
 - Recommendations (with contact info) where the remaining 3,000 kits and training equipment should go

The bottom line for STB is:

- 1. Close the Stop The Bleed program
- 2. Transfer one employee from SHGP to "other" IDPH funds
- 3. Transfer the training equipment to the Regional Health Care folks who have been doing a lot of the training
- 4. Distribute the remaining kits to schools as per Barb's recommendation
- 5. Utilize the remaining Stop The Bleed funds to acquire the necessary radios for IMERT (see next item below)

IMERT Radios & Surplus IMERT & ILEAS Team Equipment Acquisition Proposal

ITTF Chair Don Kauerauf has asked the Council of Chairs to build a prioritized list of equipment, programs and other that are currently unfunded that are ready in case surplus funds become available before June 30. Unspent grant funds is a routine occurrence as the fiscal year progresses. Don wants to have an approved prioritized list so that when money is available, they can move quickly. ILEAS worked with the ITTF LE Mutual Aid Committee (LEMAC) and other committees to come up with a list. There are two items on the list that involve ILEAS.

- 1. We submitted a request for \$50,000 for the HAVEN protective gear for Mobile Field Forces. After the civil disorder in May/June, several agencies added officers/deputies to the Mobile Field Force teams. These additional officers will require additional protective gear. The protective gear is not allowable under federal grant guidelines. As a result, ILEAS requested the \$50,000 come from the State PAR grants.
- 2. IMERT made a request to put in for \$170,000 to replace their current original radios both mobile and portable. With quotes and assistance from the ILEAS Comms staff, that amount was reduced to \$156K. The reason for replacement being they are 15 years old and not capable of using encryption that is important because of HIPPA. At the same time, MABAS made a request for \$800,000 to replace the Task Force One radios.

Given the resignation and closure of the STB program above, ILEAS will have surplus funds in the IMERT grant. The ILEAS proposal is to combine all the surplus IMERT grants plus some from ILEAS' current COMMS budget to purchase and replace all the IMERT radios. See the table below:

As you can see, there are a lot of moving pieces here. The bottom line is:

- 1. ILEAS is in a prioritized line for surplus PAR funds for HAVEN gear
- 2. The STB Program ends thereby creating a surplus
- 3. ILEAS has proposed to Chairman Kauerauf that the surplus funds from STB and current COMMS funds be combined to make the radio capital replacement complete at IMERT which he approved. This will be presented to the ITTF Council of Chairs on November 18th.
- 4. The Governing Board will have to approve the actual purchase in the December meeting since it exceeds \$100,000.
