

ILEAS Issue Document

Governing Board Meeting August 25, 2016

Business Line of Credit

At the last Governing Board meeting, members expressed concern that the Board members themselves would be liable for repaying the line of credit if ILEAS completely went out of business. The Board requested a plan for the use of the \$250,000 line of credit that would avoid that potential.

After discussion and a legal examination, staff recommends that, as a policy, the line of credit not be used to extend ILEAS' activities, but rather only as a stop gap between the exhaustion of the Business Account and the receipt of grant funds from the State. The State has now passed a budget which authorizes funds for ILEAS; however, ILEAS is waiting for the backlog of bills to be processed by the State. Staff recommends that the Board authorize staff to access the line of credit, but only for those purchases or payments that are within the budget and will be reimbursed by the State prior to date repayment is due. The line of credit should not be used for salaries. By limiting the use of the loan to pay off creditors, ILEAS' credit rating won't be impacted. Using it for salaries and then closing the doors leaves unpaid bills which will damage our credit rating which will make it even harder to reopen if that happens.

With regard to the issue of the Board members being liable for repayment, staff discussed this issue with General Counsel Mick McAvoy. McAvoy researched this issue and informally consulted with outside attorneys specializing with these types of issues. McAvoy, and the outside attorneys, determined that Governing Board members are not individually liable for debts of ILEAS. The jurisdictions who signed the LEMAA creating ILEAS likely would be responsible for the debts of ILEAS if there is a default. A discussion of how the credit holders (this could apply to any vendor actually, not limited to just a bank loan) would recover the debt would be a lengthy one.

The bottom line is:

- Individual Board members are not personally liable for ILEAS debt
- By policy, if the Board so agreed, ILEAS would not use any line of credit without the legal means to repay it so as to avoid the situation altogether
- In this instance, the line of credit would be used for paying debts and not salaries as a general rule

The Governing Board voted to approve the authorization to a \$250,000 line of credit "to be used only in cases of emergency or a significant financial situation occurs,,,," Accessing the line of credit requires approval by Jim Page or Janet Plotner AND either Derek Hagen or Dave Snyders.

Requested Board Action

Staff requests that the Board modify the June 2015 authorization to include the restriction that the approval to access the line of credit cannot be authorized without an attached written plan for repayment.

Dues Amnesty

When a member agency cannot pay dues for whatever reason, they make a request to the Board for a dues waiver. ILEAS has had a policy that agencies cannot receive equipment nor be a part of a special team if they are delinquent with their dues. We also attempt to get them to pay if they register for the conference. However, they are always able to request mutual aid regardless of their dues status. About once a year an agency requests a waiver and the Board has always granted them. There are 21 agencies that are delinquent with

their dues payments from 2013 thru 2015 are shown in the table below. They have not requested waivers – they have just not paid despite repeated attempts.

In order to clean up the books, staff is requesting the board conditionally issue a waiver on back dues for these agencies. Director Page requests that the agencies be notified that their back dues will be waived if they pay 2016 promptly.

Requested Board Action

Staff requests that the Board conditionally waive the dues of the above listed agencies for 2013 through 2015. This waiver will be contingent on the agencies paying their 2016 dues prior to September 30, 2016.

Grant Accountability and Transparency Act (GATA)

In 2014, the Grant Accountability and Transparency Act (30 ILCS 708) was enacted in Illinois. Among many other things, the GATA requires a standardized approach to State agencies issuing grants. This applies to

IEMA's Homeland Security Grants. All grantees like ILEAS are now required to go online to complete a process to determine whether or not ILEAS qualifies to manage grants. ILEAS staff is working with IEMA staff to get prepared to certified. GATA requires policies and processes that ILEAS have; however, some of those policies and practices need tweaked and updated so that ILEAS meets all the standards. ILEAS staff have prepared policy and practice updates for the Board to approve so that they are in place prior to ILEAS completing the process. These include:

- Whistleblower, Fraud, Waste and Abuse policy
 - This policy is required by the GATA process as well as specific Code of Federal Regulations (CFR)
 - The plan is to make anonymous reporting available to staff and the member agencies on the ILEAS Transparency webpage
- Audit Policy which involves the Board more formally in the audit process.
 - A policy which formally involves the Board in the selection of the auditor, review of the audit and the implementations of a corrective action plan if necessary.
- Resolution that specifically outlines what is to be included in a Financial Report to the Board
 - To standardize what the Board is presented at each meeting to include information required by CFR and GATA
- Inventory Policy to return to the practice of member agency self-certification
 - o Improve the inventory process to meet GATA and CFR standards
- Purchasing and Signatory Authority Policy outlining when bids, RFPs, quotes, etc. are to be used
- Grant Management Policy updating the requirements for grant processing

Requested Board Action

Staff requests that the Board adopt the following policies as written:

- The Fraud, Ethics and Whistleblower Policy
- The Audit Policy
- The Inventory Policy

- The Purchasing and signatory Authority Policy
- The Grant Management Policy

Staff also requests the Board adopt the Resolution (attached) outlining what information that the Board Financial Reports must include.

ILEAS Training Center Update

The Champaign County Board voted to place a quarter-cent sales tax increase on the ballot for the November election. This sales tax increase is dedicated to improving all county facilities and facility projects. Among those projects that affect ILEAS are:

- Demolition of the old hospital building and annex that ILEAS currently uses for scenario-training space
- Remodeling the B and C wing of the 1971 addition into office space for the Champaign County Sheriff so that the old downtown jail can be closed.
- Champaign County has proposed in their preliminary plans the construction of a 140' X 80' steel framed building that would replace the old hospital for scenario space.

At the point remodeling starts for the Sheriff to move in, ILEAS will have no onsite storage or scenario space. At this time, ILEAS is losing access to the old hospital due to mold growth so there is an immediate need to find a location nearby that will suffice until a new building can be constructed.

Five minutes from the ITC is Washington School in Urbana. It was an active school until two years ago when it was closed by the Urbana School District. The district has been maintaining the building which sits on 3 acres

of parking lots and sports fields. They have unsuccessfully tried to sell the building which now sits empty. ILEAS staff and the School District management have tentatively explored the option of ILEAS leasing Washington School for scenario space temporarily until the proposed new building is completed. Theoretically, this should not increase ILEAS' costs. The amount of money being paid to Champaign County for the square footage of the old hospital would then be directed to the School District for Washington School.

It should be noted that Director Page and Chief of Staff Evans met with the Director Fischer and Deputy Director Eric Pingolt twice in the last two months to talk about this and the LMS project. Page also met with Mike Schlosser, the Director of PTI, about the ITC as well. The purpose of that meeting was to ensure that what ILEAS may plan to do in Urbana, does not duplicate, but rather compliments, what PTI is planning in Decatur with its new facility.

This is just the beginning of what promises to be a detailed and lengthy discussion about the future of the ILEAS Training Center.

Requested Board Action

Staff requests that the Board authorize the staff to continue discussions with Champaign County, Urbana School District and ILETSB to develop a future plan for the ILEAS Training Center.

Communications Program Update

An update of the Communications Program activities:

What has been done to date:

- the Starcom21 user fees have been billed and paid through June 30, 2017
- the process of identifying agencies retaining individual user licenses is done & they have been notified
- the notifications of the termination of StarCom21 user fees for other agencies has been accomplished
 - The status of those notifications are:
 - 1,303 notifications sent out (272 were bad emails following up on those now)
 - 417 have responded (40% response rate)
 - 163 are keeping their radios and paying for them from this point on (Motorola notified)
 - 254 indicate they are returning their radio
 - 179 have already been returned (3 to 5 a day coming in at this point)
- the radio equipment that was recovered from Wauconda Fire has been inventoried and updated and now being stored at ILEAS
- JW Chaney, LLC. was selected and has begun the process of a complete equipment inventory and assessment for all ITECS and UCPs. We anticipate his report this Fall.
- Using FFY14 remaining funds, ILEAS has purchased:
 - 2 trailer-mounted inflatable heavy lift radio/light towers complete with mobile repeaters
 - Four solar generators
 - Three satellite radios

What needs to be done next:

- Complete the equipment assessment which will provide the basis for:
 - equipment purchasing decisions in both FFY15 and FFY16.
 - Cache radio distribution

- Building, selecting, equipping and training the Regional Technology Support Teams
- Determine what to do with the surplus Starcom21 radios that are being returned

Prior to making any significant decision about spending the approximately \$255,000 in the FY15 budget on radio equipment, ILEAS will produce a report to the Governing Board and to IEMA which outlines a specific plan based on:

- What remains at Wauconda
- The current caches and stores at ILEAS
- The team distribution of radios
- An analysis of the ITECS & UCP assessments
- The development of an overarching plan involving the Technology Support teams, field equipment and a plan for the surplus StarCom21 radios

Requested Board Action

No Board action is anticipated.

Learning Management System (LMS)

At the June 14th meeting, the Governing Board authorized staff to engage in a contract with an LMS vendor not to exceed \$45,000. Since then, ILEAS staff researched various LMS vendors, developed a scoring tool to identify at least three that appeared to have the ability to provide the service within the cost range and completed vendor demonstrations with all three. Please see the LMS Evaluation document in the Board packet for details on the selection process.

After reviewing the data collected, staff recommends engaging an LMS system called Topyx provided by Interactyx. Topyx has all the features that ILEAS needs at a low price (comparatively). Topyx offers unlimited bandwidth, unlimited users and unlimited curriculum at a steady annual rate. Staff is still working out the details of the contract. The final cost is estimated to be \$36,250 – well below the \$45,000 authorized by the Board. ILEAS plans on closing down the Adayana LMS site and moving the online training – to include radiation detectors and StarCom21 – to the Topyx LMS site. The next step is to acquire cybersecurity training designed for first responders so that it can, as well, be posted and marketed.

ILEAS staff has consulted with the following agencies during this process and have had nothing but support expressed for the LMS so far:

- Illinois Central Management Services/Department of Innovation and Technology
- Illinois Law Enforcement Training and Standards Board
- Illinois State Police
- Illinois Emergency Management Agency
- Association of Public-Safety Communications Officials (APCO)
- Illinois Telecommunicator Emergency Response Team (IL-TERT)

Some of these agencies have expressed a desire to work with ILEAS on curriculum development and to possibly partner with ILEAS to have public safety training posted on this LMS.

Requested Board Action

Since the Board approved this acquisition at the last meeting in June, no Board action is necessary at this time.
